For the upcoming June Primary Election, AltaMed will continue their partnership with the Los Angeles County Clerk Registrar-Recorder to host 13 Flex Vote Centers and 2 Mobile Vote Centers at multiple AltaMed locations from Tuesday May 31 to Monday June 6 from 8AM to 5PM.

For the first time ever and in partnership with the Orange County Registrar of Voters, AltaMed will be hosting a Pop-Up Mobile Vote Center in Orange County. The Pop-Up Mobile Vote Center will take place on Friday, June 3 for the upcoming June Primary Election. Community members will be able to vote at AltaMed's Santa Ana Bristol location from 8AM to 5PM.

AltaMed will continue to host a ballot drop box for Orange County voters at our Santa Ana - Main clinic. This ballot drop box will be available for use from May 10 to June 7.

Federal

- The U.S Department of Justice (DOJ) said it would appeal a ruling striking down the mask mandate for
 public transportation after the CDC requested its appeal. The CDC order requiring masks for travelers
 had been set to last until May 3, when many experts expected it to expire anyway.

- According to the CDC, COVID-19 was the third leading cause of death in the United States in 2021. With 415,000 COVID-19 deaths, it was the leading cause of death behind heart disease at 693,000 and cancer at 605,000. - The White House on Tuesday unveiled new steps aimed at making highly effective COVID-19 treatment pills from Pfizer more widely available to save more lives. To boost availability, the administration announced Tuesday morning that the number of sites where the pills are available would soon increase from 20,000 to 30,000, and that it will work with pharmacies to increase that number to 40,000 "over the coming weeks." On that note, the White House is also warning Congress to act urgently, as the congressional stalemate over COVID funding has forced the federal government to curtail free treatment for the uninsured and to ration monoclonal antibody supplies.

 present proof of their vaccination status and valid documents required by U.S. Customs and Border
 Protection.

- The Newsom Administration has ordered the closure of its central COVID-19 testing laboratory, cutting short a controversial no-bid contract worth up to \$1.7 billion with health care giant PerkinElmer. The California Department of Public Health notified the company that it would terminate the contract in Mid-May.

• The LA County Department of Public Health said on Thursday that the county will continue to require masking on public transportation systems, despite of the federal mask mandate on transportation systems being lifted by a federal judge in Florida. The department noted that it is issuing a health order to say that masking will be required in indoor transportation hubs such as bus and airport terminals and on all public transportation, including ride-shares, trains and buses, within Los Angeles County.

- California has enacted a health officer order and booster mandate for all health care workers.
- Boosters are necessary as antibodies and immunity can wane after about six months after initial vaccination.
- In the future, they may determine that three vaccines are in fact necessary as the primary series.
- During our last Omicron surge, many people who were unboosted had breakthrough infections and those that were older or had other medical conditions were at risk of more severe disease.
- Boosters also protect the people around you in case you have a breakthrough infection. There is a lower chance of transmitting COVID-19 to others if you are boosted.
