The market will showcase many local farm producers, artisans, agri-tourism and small business innovators. Following the market will be long table dinner, which will be prepared by top chefs in collaboration with many of these local operators showcasing local food products and producers from the County and area.

This event is designed to network and showcase what Kneehill County and the surrounding area has to offer. As a participant, this is a great opportunity to connect with a diverse group of current operators and entrepreneurs in the local food, agri-tourism and small business sector, and promote products and services to a local and international audience.

As applicable all vendor applicants will be subject to any required Alberta Health Service Special Event Vendor regulations, and must complete a Special Event Food Vendor Notification form prior to the event. Please note this is a grassed area which experiences some heavy wind gusts so vendors are required to bring appropriate securement devices for their tents and displays. Organizers will provide vendors with this form and the appropriate information. Each vendor must also provide a certificate of insurance stating General Liability coverage with a minimum limit of \$1 million coverage for bodily injury or property damage to a third party (public liability) showing in relation to this specific event.

The undersigned agrees to assume and hold harmless Kneehill County, its officers, employees and agents (collectively the "Indemnified Parties") from all liability to any person or property of whatsoever kind or nature which occurs as a result of activities for which they were granted by Kneehill County (except to the extent arising out of the Indemnified Parties' breach, negligence or willful misconduct).

Further, agrees to indemnify and defend, saving harmless the Indemnified Parties against any liability, or claims of liability, brought or made on behalf of any person for personal injury or property damage caused by or arising out of any act or omission of either the undersigned, their agents or employees, and occurring during the period and as a result of the activities for which this vendor
