- PROOF OF ADDRESS IN THE CITY OF HARTFORD.

Proof of address documents must be dated within 30 days from card application date. Provide one (1) document from the following list:

- US utility Bill (Phone, Electricity, Gas, Heating, Water or Internet)
- US Current residential rental or lease agreement
- US employment pay stub
- 4. US bank account or credit card statement
- Hartford property tax statement dated not more than one (1) year prior to the date application is submitted.
- Mortgage payment receipt for real state property located within Hartford
- Bill for homeowner, renter, health, life or automobile insurance
- Jury summons or court order issued by a federal or state court
- Federal or state income tax or refund statement dated not more than one (1) year prior to the date of application
- Written verification issued by a homeless shelter located in Hartford confirming at least 15 days of residency
- Written verification issued by a hospital, health clinic, or social agency lacated in Hartford confirming at least fifteen (15) days residency

#### CARD APPLICATION GUIDELINES

- Application process MUST be completed in person at the enrollment centers
   Providing false or misleading information to
- obtain the Hartford City ID card is against the law 3. All documentation submitted MUST be original copies with no alterations or signs of tampering
- No document can be used to fulfill more than one application requirement
   Primary Proof of ID documents Expired No more
- Primary Proof of ID documents Expired No more than five (5) years prior to date of application are acceptable
- 6. A married applicant or a minor can use proof of city residency documentation bearing his/her spouse's, parent's or legal guardian's name to meet the city residency requisite to apply for the card
- Underage applicants must be accompanied by a parent or legal guardian. Proper documentation must be presented to establish the legal relationship between the underage applicant and the accompanying adult
- 8. The Hartford City ID card is valid two (2) years from date of issuance
  9. If two Primary Proof of ID documents are used for application, no Secondary Proof of ID document

# ■ ENROLLMENT PROCESS

is required

- Confirm you have the correct documents to apply (see card application check list).

   Identify and visit a preferred enrollment center:
- Hartford Public Library, Downtown Branch and the Office of Town and City Clerk. You must apply for your card at an enrollment center.
- Your Hartford City ID Card will be mailed to the address listed on your application in 10-15 business days. If selected, cards can be picked up from enrollment center approximately 15 days later.

### ■ PRIVACY & CONFIDENTIALITY

The City of Hartford will protect the confidentiality of all City ID card applicants to the maximum extent allowable by applicable federal and state law, and in accordance with local Municipal Code Article XXIL Sec 2-395.
