The meeting was called to order by Yvonne Matthews at 6:15. About 30 participants introduced themselves.

The Mission of AHNA was read. Chris Chanaca is being promoted to Sargent and will be helping to find his replacement. Yvonne recognized Liz Gustafson, the Social Work intern from UCONN School of Social Work, and also welcomed Morgan Ferrarotti back from maternity leave.

Police Report: Ofc. Chris Chanaca, reported that crime was down in March significantly, 1 robbery, 4 burglaries, 5 car breaks and 2 stolen vehicles. There had been 3-7 special assignment in AH & West End, but lately they have been called to the North End. Still biggest problem is the panhandling etc. on Farmington Ave.

The March minutes were reviewed and approved.

City of Hartford Update – Janice Castle: Janice is responsible for all citizen concerns as well as communicating department issues and Mayor's Town Hall meetings:

- Communication to store owners regarding maintenance
- Created a map of Hartford showing the neighborhoods and the NRZs for each
- 311 card explaining the best way to reach all City Departments
 - a question arose about the responsibility of City employees to call in issues rather than the citizens, it was explained that all of us need to work together to report whatever needs to be done.
- Explanation of the new Speed Hump protocol as reported in the N&V
- Hartford 311: Janice shared a card indicating ways to access 311, a non-emergency call center designed to connect residents with city services.
- City ID available in April: ID will be available to all Hartford residents. The City will not retain any personal information.

Guest Saint Francis Hospital:

- Bob Falaguerra, VP at Saint Francis introduced the location of the demolition needed to allow for the new construction. The existing buildings house one year residents and the hospital that can be absorbed into the existing neighborhood housing. An existing daycare center will be relocated to 1075

C-Tec Solar: Tyler Cazzetta presented the **Solarize Hartford** campaign in which they were the chosen contractor to offer PV solar installations to Hartford homeowners.

- Only available to owner occupied homes up to 3 family with a single electric meter.
- Some homes may not qualify due to historic requirements and orientation of the southern exposure
 - They are happy to consult and make a site visit at no charge
 - Leasing and financing are available – units have a 40 year life expectancy
