Executive Director's Report: Because he was delayed on his return from Florida, David was unable to give his report.

REPORTS FROM THE CITY:

- Police Department Report:** Asylum Hill's CSO, Sid Palmieri, (palmc002@hartford.gov) reported he is now working night shift to help decrease incidents of larceny. He encouraged residents to remove valuables from their cars. He's concerned about an increase in public drinking, especially in the morning; he's encouraging stores not to sell liquor in the morning. He is addressing complaints about loud music in Sigourney Park.
- Fire Department Report:** Lt. Jesus Lopez, (860-757-4523), Special Services Unit reported the most recent stats for Asylum Hill. Hartford reports 16,818 cases of COVID.

- **CITY Update:** Andrene encouraged residents to get vaccinated. They can call 311 for locations, or check the weekly newsletter from the City. National Night Out will be in 4 locations on Aug 3.
- **Hartford Planning Department Update:** Paul Bengston reported approval of three projects. He reminded residents to visit meetinginfo.org for an update on all committees. He announced the South Branch Train Project public meeting August 18.
- **Community Court Report:** Doug Ovian (douglas.ovian@jud.ct.gov) reminded residents that the Community Court is now fully open. Community Service has begun.

Committee Reports:

- **Economic Development:** St. Francis Hospital is planning some major renovations.
- **Quality of Life:** met recently to identify various safety problems in Asylum Hill including the need for more crosswalks.
- **Green Committee:** the Energy Fair Festival will be Oct. 16 from 1-5. The next meeting will be Aug 9 – focused on the north branch of the Park River.

Review of Minutes: The May General Meeting minutes were approved. The June minutes were approved with an amendment that the Communications' Committee's report be attributed to the Green Committee.

Covenant Prep School: Lisa Tica described the work of the boy's school for grades 6-8. She encouraged residents to consider Covenant Prep.

Hartford Community Loan Fund: Rex Fowler described a landscaping proposal for 207-215 Garden St. He requested a letter of support for the improvements. It was approved. He then shared concerns about the many accidents that have occurred by his building. He requested a letter of support to the City requesting traffic calming initiatives on Garden Street. The YWCA supports this effort. This request was referred to the AHNA Board.
