#### The Carole Stanley Memorial Trophy

Proposal from Libby Lewitt, Mary Allen, Joe Reno, Susan Minard, Judie Evans, Nancy Anstruther, Tami Scowden Conrad, Dianne Bishop and friends of Carole Stanley.

Carole's 53 years that she gave to the collie breed can be characterized by one word her "generosity" to her friends, fellow breeders, new breeders and her mentoring of new exhibitors in the collie family and she continued to support to the Collie Club of America working with the Education and Judges Committee's as well as District Director for her home state of Michigan.

She began as an exhibitor showing other people's dogs in Michigan and that's where she began being mentored by Irma Ransom, Ransom Collies and Helen Zavalney, Lindhurst Shelties. She then produced CH Laurien's Afterhours Blues "Kelly" who produced 19 champions within two years. She then went on to produce:

CH Donnybrook Afterhours Silk – BOS to BOV - CCA 1989 CH Afterhours Firestorm – WD – CCA 1994 CH Ladyvale Afterhours Electra WB/BOW – CCA 2006

CH AKC/CKC - Afterhours Color of the Wind ROM Afterhours Risque ROM Afterhours Debutante Velvet Clouds ROM CH Afterhours Sands of Time ROM

She owned CH Emperor's Afterhours Tryst ROM one of the top producing smooth bitches with 18 champions which lead Carole to breeding smooth collies.

Carole's generosity also included supporting her fellow breeders by hosting stud dogs at her kennel so that others could take advantage of their quality. This included CH Clarion True Colors, CH The Meadow's Notorious ROM and CH Gambit's A Hurricane Brewin' ROM to name a few. Carole also placed many of her collies with new exhibitors and her Afterhours name was secondary to many other kennels. If you received a puppy from Carole, she was your mentor and friend for life.

Carole was approved as a Judge for Collies, Shelties and Juniors in 1992. She felt the highlight of her career came when she was asked to judge Dogs at the 2012 Collie Club of America National in Philadelphia, PA. Carole was also asked to judge the Collie Club of Canada National in 2017 enjoying the collies of Canada.

Carole was most proud of her accomplishments as a breeder because she loved breeding puppies. She often shared the story of how Mrs Browing of Tokalon fame that when left with two spayed bitches she could no longer breed. Carole empathized with that collie icon because her greatest joy was the chance to make one more breeding which could produce the next great collie.

From those of us who have been mentored, admired all her accomplishments, her friends and appreciate her contribution to the collie breed we are proposing to offer this memorial challenge trophy in her honor for Breeder of Best Puppy (Rough or Smooth) at the 2023 Collie Club of America National. The trophy is a portrait by Cindy Alvarado valued at \$2800. The portrait is 24 inches by 28 inches by 1½ inches framed and will include a separate plaque 8 inches by 10 inches by 2 inches to include the tags for winners names to be recorded to be stored in a customized case from Star Case Company to be used to transport the trophy safely from national to national from person to person.

The statement was developed by Breed Education Committee and Collie Health Foundation with final review by our Health Policy chairman, Alisa Harbin, DVM.



#### COLLIE CLUB OF AMERICA HEALTH STATEMENT

#### March 1, 2022

The three tests that are highly recommended and generally accepted in a good breeding program are the MDR1 test, the PRA test, and the DMS test.

First the MDR1 (Multidrug sensitivity) test - It is a genetic test with clear understandable results. We know that it is widespread and can identify normal, carriers and affected. Many collies have at least 1 of the genes (carrier), or both (affected). This genetic defect allows certain drugs to cross the blood/brain barrier and sometimes severe neurological symptoms can result, depending on the drug and the amount given. Each group varies on the response to certain medications. Many of these medications are used to treat a wide range of conditions and/or diseases in collies, so it is extremely important that the results are known prior to having to use any of these drugs.

Second is the PRA (progressive retinal atrophy) test - This is also a genetic test with clear understandable results. We know that it is not as common as some genetic diseases, but in the past the only way to find carriers was to do test breedings to PRA blind bitches and hope for enough puppies to make it significant. This is no longer necessary. The genetic test tells us normal, carrier and affected (the affected is known to cause blindness). This is a good test to include because of the severity of the disease.

Additionally, puppies should have an eye examination by a certified veterinarian ophthalmologist prior to going to a new home.

Third is the DMS (Dermatomyositis) test – This is an inflammatory auto-immune disease affecting skin or muscle and both in extreme cases. This test allows breeders to select an appropriate sire or dam to produce more genetically lower risk progeny.

There are many other optional tests that may be done to ensure a healthy collie including, but not limited to CEA (collie eye anomaly), Hip radiographs (OFA or PennHip), Hypothyroidism, and Degenerative myelopathy.

**CHIC DNA Banking Project**

CHIC (Canine Health Information Center) is sponsored by AKC/Canine Health Foundation and Orthopedic Foundation for Animals. Contributing to this project will be one of the most important things you can do to preserve the future of the Collie breed. With the gene pool of all purebred dogs shrinking, breeders need to make health testing the cornerstone of their breeding program. With your help, we will have a DNA bank that all approved researchers will have access to when they need samples for genetic research projects. As a donor, you will have access to your dog's DNA when new tests become available. By banking blood samples, DNA will be extracted from the blood and then held at the University of Missouri. OFA believes this process will preserve the DNA forever. Please be a part of helping CHF and AKC/CHF researchers find genetic markers for bloat, epilepsy, cancer, and so many other health issues. Having samples available when new research studies become available will cut down the time for samples to be made available to researchers and lead to positive conclusions much faster.

- CHF will pay the \$20 CHIC DNA Banking Fee for all Collies
- CHF will reimburse (with receipts) up to \$125 for collection and shipping costs. Please do <u>multiple dogs</u> at a time to keep these costs under control. You are welcome to send healthy dogs in at the same time to be part of the control group.
- CHF sponsored a DNA collection clinic at the Collie Club of America National Specialty Show in Virginia Beach in 2018. It was co-sponsored by the Orthopedic Foundation for Animals and the American Kennel Club/Canine Health Foundation. Cindi Bossart, VMD managed the clinic. The CHF is working on this type of project for the future CCA National events. So far nothing has been arranged for CCA 2022 in Utah, but watch for announcements in the coming years in 2023 (Fort Wayne IN), 2024 in (Peoria IL), or 2025 in (Syracuse, NY).
