2021 National - Statement to the Board

The 2021 National, *Welcome to Colliewood*, in **Cheyenne, Wyoming** ended at the expected strong financial position. In total, the show had a profit of \$8,508.61.

Total income was \$140,700 and very typical of a National this size. Total entries of \$43,827 was on budget. Agility income of \$4,900 was down versus expectations. Herding income (\$8,690) was higher than expectations. Merchandise sales (\$12,825) and grooming space sales (\$10,434) came in at expectation. Total trophy income (\$22,988) came in slightly higher than expectations. The agility fundraiser generated net income of \$3,961 which met expectations. The show received support from the local Chamber of Commerce with a \$4,290 donation to help offset expenses. Total expenses were on plan at \$132,192 and driven by significantly lower site expenses of \$13,547 versus other Nationals (not including Peoria) while merchandise (\$6,142) expenses were better than expectations. Merchandise had a net gain of \$6,683. Trophy expense came in at expectation at \$14,631. Trophies had a net gain of \$8,357. The 50% state basket payout of \$1,498 was sent to the Collie Health Foundation.

The Conformation/Obedience and Rally part of the show showed a net gain of \$676. It is uncommon for this part of the show to have any profit and in this case it was driven by the significantly lower than normal facility costs and the Chamber donation. Other than herding and agility incomes, all other income and expenses met expectations.

Herding had a net profit of \$4,758. This was a pleasant surprise as our herding events during National Week traditionally have a net profit of \$500 - \$1,000. In this case, strong entries drove the bottom line.

Agility had a net profit of \$3,074. Without the agility fundraiser, the National Week agility trials would have had a loss of ~\$887. This was a surprise as agility typically delivers a rather significant profit. Past agility events during National Week typically deliver a net profit of \$650-\$5,000.

All in all, a job very well done by all. Congratulations to Show Chair, Robette Johns, and her team!

Pursuant to Show Rules, the show profit of \$8,509 will be reduced by the 25% due to the clubs which supported the show. In this case, the 25% equals \$2,127.15. This amount will be equally split between five (5) Clubs with \$425.43 going to each club. They are California Collie Clan, South Bay Collie Fanciers, Los Padres CC, Sacramento Valley CC and Southern California CC.

Net of the payout, the final show profit to the CCA is \$6,382.

On November 15, 2021 I received notice from Willis of New York, our D&O insurance broker, that they will be leaving the nonprofit D&O insurance business effective January 1, 2022 and will no longer offer D&O coverage. Our D&O

coverage was for \$2MM with a \$2,500 deductible. We purchased the insurance through Willis. The annual premium was \$1,760.

On December 7, 2021 I was able to obtain D&O coverage from Great American Insurance Group with help from Sportsmen Insurance Agency (who we use for our show liability and trophy coverage). The coverage is for \$3MM with \$0 deductible. The effective start date is December 7, 2021. The 2 year premium is \$2,245. We purchase the insurance directly from Great American. You will see the first year payment of \$1,122.50 in the January 2022 Club financial reports.
