**Constitution - Article II, Section 5** If a membership has been terminated by lapsing, the membership is entitled to reinstatement for a period of one (1) year (before December 15 of the following year) which will require the payment of a reinstatement fee, submittal of a reinstatement form, and the affirmative vote of two-thirds (2/3) of the Voting Directors present at a meeting where a quorum is present. Once a membership has been lapsed for one (1) year, (after December 15<sup>th</sup> of the following year), the lapsed member shall not be entitled to reinstatement and must formally apply for membership as a new member in accordance with Section 3 of this Article.
