## 2022 FortiEDR Incentive Terms and Conditions

1. To be eligible for FortiEDR incentive, claims must include a valid Deal Registration ID, End-User Company name, Distributor invoice, and invoice must include at least one FortiEDR product.
2. Only SKUs that include “EDR” will be included in total amount, which dictates payment band. Total invoice amount (i.e. invoices that include both EDR and non-EDR products), does not determine payment band. Only EDR SKUs are eligible for this incentive
3. This program starts on April 1, 2022 and ends at 11:59 pm PT on December 31, 2022 - “Program Term.”
4. Excludes renewals, co-terms, training, professional services, and RFPs. 5-year SKUs will only be counted at 60% of the invoiced amount.
5. Deal Registration must be registered **by the partner** (*not internal Fortinet rep*) and show in the Fortinet Partner Portal [opportunity dashboard](#) as Closed/Won to qualify.
6. Deal Registrations cannot be split
7. Program is only valid for deals registered in Canada or USA
8. Deals must be closed during Program Term and distributor invoice must be dated within promotional period to qualify (April 1, 2022 through December 31, 2022).
9. Invoiced amount must be  $\geq \$10,000$  (USD) before tax and shipping. CAD invoices will be converted to USD using exchange rate from date of invoice. If necessary, payment band will be updated to validated invoice amount.
