#### 3. SLIDE Update on federal grants changes

- Background: 8/7/2025 EO Improving Oversight of Federal Grantmaking
- Discretionary grants:
  - o must...demonstrably advance the President's policy priorities.
  - (ii) shall not be used to fund, promote, encourage, subsidize, or facilitate:
    - (A) racial preferences or other forms of racial discrimination by the grant recipient, including activities where race or intentional proxies for race will be used as a selection criterion for employment or program participation;
    - (B) denial by the grant recipient of the sex binary in humans or the notion that sex is a chosen or mutable characteristic;
    - (C) illegal immigration; or
    - (D) any other initiatives that compromise public safety or promote anti-American values.
- Example wording: "Compliance with Federal civil rights and nondiscrimination laws is material to the government's decision to make any award and payment under this program, including for purposes of the <u>False Claims Act</u>, and each recipient will be required to certify (in its acceptance of the conditions of the award) that it does not operate any programs (<u>including any such programs having components relating to diversity, equity, and inclusion</u>) that violate any applicable Federal civil rights or nondiscrimination laws."
- Funds can't be used for "programs or activities that violate, or encourage the violation of, federal immigration law"
- What counts as DEI "encouraging violation of immigration law"?
  - Undefined

- Speculation: <u>Forbes trigger word article</u>
- Federal discrimination law still applies
- Changing wording on public-facing communications while continuing prohibited work is prosecutable under the False Claims Act
  - Federal whistleblower protections apply
- Termination for convenience clauses allow award cancellation if they no longer align with policy priorities or "national interest"

#### 4. Unchanged: Federal grant application process can be complex

- Standard: Obtain UEI through SAM.gov, complete SF-424 in Grants.gov, register with individual grants management system (JustGrants)
- Look for "key dates and times" in NOFO for deadlines

#### 5. Decision matrix

- Read NOFOs carefully (multiple reads recommended)
- Does your work align with the grant goals and administration's priorities?
- What is the funding instrument, and does it align with your needs?
  - o Grants: Often require upfront expenditures with reimbursement
  - Cooperative agreement: "substantive involvement" of agency
- Does your work or any communications about your work violate their requirements?
  - Does the organization have DEI-related goals, populations of focus, etc.?
  - o Do you serve undocumented individuals?
  - Legal advice needed
- Do you already have UEI and previous registrations with federal systems?
  - o UEI takes up to 10 business days and must be renewed annually
  - Confirmed authorized representative?
  - Registered in federal agency's grant management system (e.g., JustGrants)
- Do you have successful federal grant narratives you can build on?
- If required, do you have an updated logic model, evaluation framework, and program data readily available?
- Do you have the resources and bandwidth to dedicate to moving quickly and accommodating short timelines?
  - o Prep time varies widely but general guideline is 100 hours, all-in
  - Budgets and finance person to address related required documents?
  - Legal counsel to mitigate risk and aid and ensure compliance?
  - Program or other staff ready to provide information quickly and respond to drafts?
  - Existing MOUs/letters of intent with existing partners (if applicable)?
