SUBMISSION GUIDELINES

- 1) Submitted entries will be based on a 12 month period.
- 2) Submission material requirements:

The following must be submitted, no later than December 31st, in order to be considered for the award:

- (a) Chapter Annual Report
- (b) Article summarizing the activities of the chapter
- (c) Supporting material (e.g., chapter newsletters, education program flyers, etc.)
- 3) All submissions must be sent to the CLSA Central Office no later than December 31st.

SELECTION COMMITTEE

The Selection Committee shall be the Executive Committee consisting of the CLSA Officers, Executive Director and two members of the Board of Directors.

AWARD

This award consists of a plaque which will be presented to the Chapter President at the CLSA Annual Conference. An article may be published in the California Surveyor featuring the programs and accomplishments of the chapter.

MEMBER OF THE YEAR AWARD

PURPOSE

The Member of the Year Award was created to recognize and honor an individual member of CLSA who has demonstrated outstanding volunteer service through his/her commitment, leadership, professionalism, and dedication in service to California Surveyors.

SELECTION CRITERIA

This award is presented to the most outstanding Member for the previous year. The most outstanding member is considered to be the person who has best supported and promoted the objectives of CLSA and who has contributed most to CLSA activities at the state level. The following guidelines will be used in, but not limited to, making a selection:

- 1. Participation on CLSA Committee(s)
- Participation a special projects or tasks that resulted in a positive asset to the association and/or profession, or to the public perception thereof
- 3. Demonstrated ability to enhance the land surveying profession by mentoring new surveyors, working with those in the profession who are pursuing a land surveying career
- 4. Attendance and participation at CLSA events
 - a. Board of Directors meetings
 - b. Committee meetings
 - c. Seminars/Workshops
 - d. Conference
- 5. Submission of articles to CLSA publications (California Surveyor or CLSA NEWS)
- 6. Exhibited commitment to promoting membership in the Association
- 7. Promotion and support of the ideals and objectives of CLSA

WHO IS ELIGIBLE?

Any Corporate member of the California Land Surveyors Association in good standing is eligible for nomination as Member of the Year. Elected officers of the Association are excluded from consideration for this award during their term of office.

NOMINATION PROCESS

Nominations may be made by an individual CLSA Member or by a CLSA Chapter. Nominations will only be deemed valid when submitted to the CLSA Central Office on an official Member of the Year Award Nomination Form received or postmarked by **December 31st**. It is the Executive Committee's discretion to not award a winner.

SELECTION COMMITTEE

The Selection Committee shall be the Executive Committee consisting of the CLSA Officers, Executive Director and two members of the Board of Directors.

FREQUENCY OF AWARD

The award will not be given more than once a year. Recipient will be recognized at the CLSA Annual Conference.

AWARD SPECIFICS

The award will be a plaque and complimentary registration to the CLSA Annual Conference.

DOROTHY CALEGARI DISTINGUISHED SERVICE AWARD

WHO IS ELIGIBLE?

Any member of the California Land Surveyors Association in good standing is eligible for nomination for the Distinguished Service Award. If a person has received a Distinguished Service Award, he or she is not eligible to receive the same award again.

NOMINATION PROCESS

Nominations will only be deemed valid when submitted on an official Distinguished Service Award Nomination Form by December 31st.

SELECTION COMMITTEE

The selection committee shall be the Executive Committee consisting of the CLSA Officers, Executive Director and two members of the Board of Directors.

SELECTION CRITERIA

This is CLSA's highest service recognition. As such, the recipient must demonstrate exemplary service to the profession extending beyond the chapter/local level for an extended period of time. The following guidelines will be used in, but not limited to, making a selection:

- Significant contributions to the advancement of the profession and/or the public that stands as a model of professionalism, dedication, and commitment of moral conduct by a professional land surveyor
- 2. Contributions over an extended period of time, as opposed to a single or short-term effort
- Record of leadership and long-term commitment to service through professional activities and involvement
- 4. Integrity and character deserving of the award

FREQUENCY OF AWARD

The award will not be given more than once a year. Recipient will be recognized at the CLSA Annual Conference.

AWARD SPECIFICS

The award will include a plaque and complimentary registration to the CLSA conference.

CHAPTER NEWSLETTER AWARD

AWARD CRITERIA

Previous year's award winner is ineligible to participate. Chapters nominate themselves by including the CLSA Central Office on their mailing/email list, as well as submitting the Chapter Newsletter Award Submission form, along with 4 consecutive issues of their Chapter Newsletter, postmarked no later **than December 31st** of each year of the award. Submissions will be considered on the criteria listed below.

- Consistency and timeliness (10 points): the newsletter is disseminated at least four times a year at scheduled times.
- Pertinent content (40 points): chapter news, CLSA news, professional development opportunities, articles related to the profession, recommended reading, etc.
- Effective writing (20 points): most creative, informative and accurate presentation of information. Well-organized, clear purpose, engaging voice, fluent, balance of in-depth and brief articles, use of original material, etc.
- Purposeful publication (10 points): the chapter's goals are clear and help organize the publication.
- Layout (10 points): formatting aids the reader in locating information
- Graphics (10 points): artfully organized, guide the reader's eye, enhance presentation of ideas and information, e.g. photos of chapter events, speakers at conferences, columnists, etc.

SELECTION COMMITTEE

The selection committee shall be the Executive Committee consisting of the CLSA Officers, Executive Director and two members of the Board of Directors.

FREQUENCY OF AWARD

One newsletter will be selected and recognized at the CLSA Annual Conference. In addition, up to two honorable mentions may be made.

AWARD SPECIFICS:

The award will consist of a plaque presented to the winning chapter. The editor of the winning newsletter will receive complimentary registration to the CLSA Conference. Chapters receiving honorable mention will receive a certificate.

PURPOSE

AWARD CRITERIA

All officially chartered chapters are eligible for this award. Previous year's award winner is ineligible to participate.

Submissions will be considered on the criteria listed below.

- Content (40%): Information about the chapter, officers, calendar of events and industry news.
- Functionality (20%): Use of technology for easy navigation though the site.
- Appearance (20%): Professional appearance that reflects well on the Chapter and CLSA.
- CLSA (20%): Chapter maintains pages on the CLSA main website, Chapter supports CLSA by providing information on their website for statewide events such as the conference.

SELECTION COMMITTEE

The selection committee shall be the Executive Committee consisting of the CLSA Officers, Executive Director and two members of the Board of Directors.

FREQUENCY OF AWARD

One website will be selected and recognized at the CLSA Annual Conference. In addition, up to two honorable mentions may be made.

AWARD SPECIFICS:

The award will be a plaque presented to the winning chapter at the conference. Chapters receiving honorable mention will receive a certificate.
