NGA's President: Committed to Good, Ethical & Benevolent Guardianship

- #Guardianship Data Transparency: we need to collect data so we can empirically quantify all of the vital public services that guardianship provide to those needing protection, policymakers should make data-driven decisions & not knee-jerk reactions based on anecdotal “stories”.
- #Silver Collar Crimes: the number #1 pipeline into guardianship is exploitation by family members and others in close proximity to their loved ones, often guardians and the courts have to rescue these victims, then sometimes the perpetrators are the very same people who hinder guardianship services.
- #Public Guardian Funding: Public policy should match state appropriations, guardians should not be forced into pro-bono appointments, we need more funding for public guardianship, and professional guardian should be well and fairly compensated.
- #Certified Guardianship Investigator: the NGA is developing specialized training and education for guardianship auditors, investigators, reviewers, monitors, law enforcement officers, prosecutors, APIs, etc., we will teach these investigators empathy for good, ethical, and benevolent guardianship.
