Substantial	Close school(s) for 3-7 days	Close school(s) for 14 days

For Schools 500 – 900 students

Level of Community Transmission	Number of Cases of COVID-19 Within a Rolling 14-Day Period: 4-6 students/staff in same school building	Number of Cases of COVID-19 Within a Rolling 14-Day Period: 7+ students/staff in same school building
Substantial	Close school(s) for 3-5 days	Close school(s) for 14 days



New School Closure Recommendations

For Schools > 900 students

Level of Community Transmission	Number of Cases of COVID-19 Within a Rolling 14-Day Period: 6-10 students/staff in same school building	Number of Cases of COVID-19 Within a Rolling 14-Day Period: 11+ students/staff in same school building
Substantial	Close school(s) for 3-5 days	Close school(s) for 14 days




Attestation Option 1

- High likelihood school closures for next week:
 - Norwin High School 14 day closure
 - currently 10 active cases
 - Norwin Middle School 3 to 7 day closure
 - currently 4 active cases
 - Sheridan Terrace and Stewartsville 3 to 5 day closure
 - Currently 3 active cases in each school





Why Option #2 for Next Week?

- Student and Employee Safety
- Decreases the chances of in school transmission
- Decreases the chances of mandatory school closures
- Allows the District four student days to conduct pilots of synchronous learning
- Our intention is to resubmit our Attestation form next Friday in order to transition to Hybrid with synchronous learning starting Monday, December 7th.

Incidence Rate per 100k




Incidence Rate per 100k

Incidence Rate per 100k


