- Camp Hidden Lake is open for students who are currently in 5th grade to teens currently in 8th grade
- We will depart from St. Mary's around 6am on July 25, 2022, and will return to St. Mary's around 9pm on July 30, 2022
 - o Times are an estimate and are subject to change, parents will be notified of the change and will be kept updated on arrival time back to Mobile
- Cost of the trip is currently \$560 plus travel costs (we will be taking a Gulf Coast Tours bus)
 - o This cost is subject to change dependent upon fundraising and donations
 - o If you would like part of the fundraising to be applied to your child's cost, your child must help with and attend the fundraising events (more information on this will be given)
