KINDERGARTEN REGISTRATION REQUIREMENTS

Earlington – Grapevine – Hanson – Jesse Stuart – Pride – Southside – West Broadway – West Hopkins

1. KRS158.030 - any child who is five (5) years of age or who may become five years of age by **August 1**, may enter a public school kindergarten.
2. Kindergarten is compulsory. All children must attend.
3. All children not presently enrolled in kindergarten who will be six (6) years old by August 1, 2018, **MUST REGISTER**.
4. Kindergarten students must present proof of age with **Certified Birth Certificate** or other reliable proof of age and identification.
5. Kindergarten students must have an **up-to-date Kentucky Certificate of Immunization** within two weeks of the child's enrollment.
6. Kindergarten students must have a **preventative health care exam** conducted within one year prior to school starting.
7. Kindergarten students must have a **KY School Eye Exam by an optometrist/ophthalmologist** no later than January 1.
8. Kindergarten students must have a **dental screening or examination** documented on the **KY Dental Screening Form** no later than January 1.
9. **Students must register for Kindergarten at the elementary school in their attendance area.**
10. Students who attend kindergarten at PAROCHIAL SCHOOLS should register and **MUST** be (6) years old by August 1, 2018, to be eligible to enroll in First Grade in Hopkins County.
11. A parent or guardian may petition the district to allow a student who does not meet the age requirements to attend kindergarten.
12. No registrations by phone will be accepted.
