- 3. To not expend any grant funds for any political or lobbying activity or for any purpose other than the one specified in this application.
- 4. To allow Green Cities Foundation to review and approve the content of any proposed publicity concerning this grant prior to its release and to recognize Green Cities Foundation in all publicity materials related to the funded project or program, as specified in the grant notification letter.

Your reports should describe your progress in achieving the purposes of the grant and include a detailed accounting of the use and expenditure of grant funds.
