## MOTIONS PASSED

The second reading of the motion to change the Bracket Size Adjustment Factors for KO Team events which apply to the play and awarding of Masterpoints in semifinal and final matches will be effective January 1, 2019.

The second reading for revising Masterpoints for Regular Club Games passed and becomes effective January 1, 2020.

The rating of Session Awards for Flight C NAP District Finals be adjusted from 50% of Regional rating to 62.5% January 1, 2019.

The table fees for clubs holding short games (12 to 17 boards) will increase from \$0.55 to \$0.58 as of April 1, 2019.

Entry fees at NABCs will be \$30 for NABC+ events, \$22 for other NABC events, \$20 for regional events and \$20 for unlimited single session events, effective June 1, 2019.

\$10.00 per session/per pair and \$20.00 per session/per team will be added to all events at NABC's at the point screens are introduced, effective June 1, 2019.

Districts in which there are at least eight teams competing in a B and/or C flight in the Grand National Teams (GNT) District Final, may send a second team to compete in the National GNT Finals.

A player who has won an event that would qualify that individual to be designated Grand Life Master when 10,000 masterpoints are accumulated, will automatically be entered into the top strat of flighted KO events, open stratified Swiss events, bracketed KO and Swiss events and Flight A of a Flight A/X Swiss, effective January 1, 2020.

A Masterpoint Committee will be formed, consisting of a minimum of seven members, three of whom shall be appointed at-large by the Board President upon consultation with the Chairman of the Board of Governors, two of whom shall be

members of the Board of Directors and two of whom shall be ACBL employees appointed by the Executive Director.

A Board Oversight Committee will be formed to investigate and report its findings and recommendations to the Board of Directors regarding issues of conduct by Board Members. The committee will consist of the Chairman of the Board as the committee chairman and the two most immediate past presidents currently on the Board.

The ACBL recognizes the North American Bridge Federation as the Zonal Conference (Authority) for Zone 2, which consists of the following for International World Bridge Federation Play: a. United State Bridge Federation, b. Canadian Bridge Federation, c. Mexican Bridge Federation.
