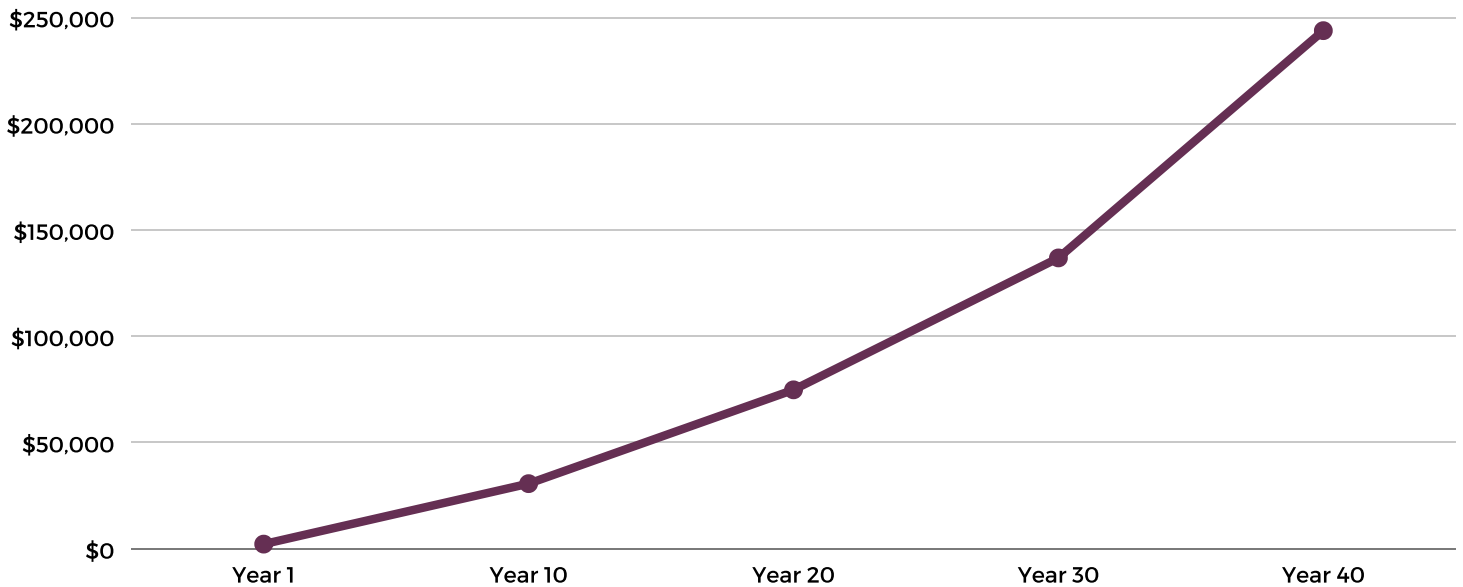

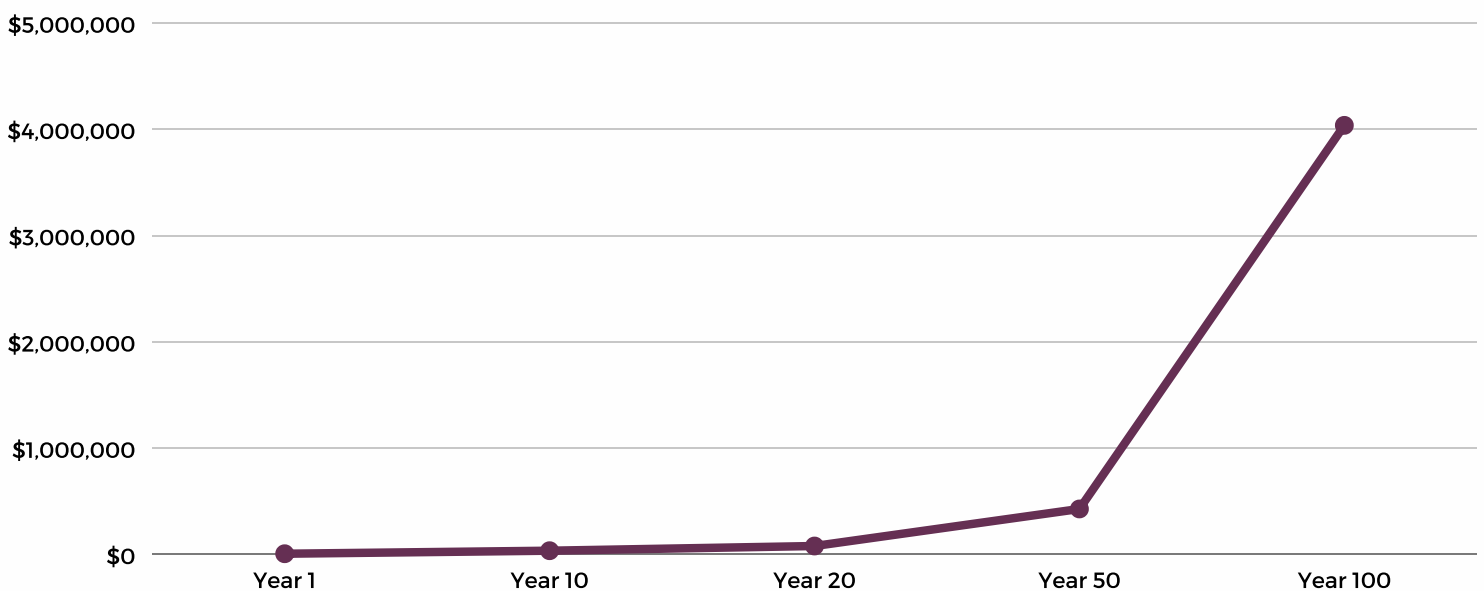
\$165,000 DEATH BENEFIT AT AGE 0
