1 **AN ACT** *to repeal* 84.54 and 86.51; *to amend* 66.0129 (5), 66.0903 (1) (c),
2 66.0903 (1) (f), 66.0903 (1) (j), 66.0903 (1m) (b), 103.005 (12) (a), 103.503 (1)
3 (a), 103.503 (1) (e), 103.503 (2), 103.503 (3) (a) 2., 109.09 (1), 111.322 (2m) (a),
4 111.322 (2m) (b) and 978.05 (6) (a); *to repeal and recreate* 66.0903 (1) (g)

Analysis by the Legislative Reference Bureau

Prevailing wage

This bill requires that laborers, workers, mechanics, and truck drivers employed on the site of certain projects of public works be paid the prevailing wage and not be required or allowed to work a greater number of hours per day and per week than the prevailing hours of labor unless they are paid overtime for all hours worked in excess of the prevailing hours of labor. Projects subject to the bill include

state and local projects of public works, including state highway projects, with exceptions including projects below certain cost thresholds, minor service or maintenance work, and certain residential projects. Under the bill, “prevailing wage rate” is defined as the hourly basic rate of pay, plus the hourly contribution for bona fide economic benefits, paid for a majority of the hours worked in a trade or occupation in the area in which the project is located, except that, if there is no rate at which a majority of those hours is paid, “prevailing wage rate” means the average hourly basic rate of pay, plus the average hourly contribution for bona fide economic benefits, paid for the highest-paid 51 percent of hours worked in a trade or occupation in the area. “Prevailing hours of labor” is defined as 10 hours per day and 40 hours per week, excluding weekends and holidays. The bill requires the Department of Workforce Development to conduct investigations and hold public hearings as necessary to define the trades or occupations that are commonly employed on projects that are subject to the prevailing wage law and to inform itself of the prevailing wage rates in all areas of the state for those trades or occupations, in order to determine the prevailing wage rate for each trade or occupation. The bill contains certain other provisions regarding the calculation of prevailing wage rates by DWD, including provisions allowing persons to request recalculations or reviews of the prevailing wage rates determined by DWD.

The bill requires contracts and notices for bids for projects subject to the bill to include and incorporate provisions ensuring compliance with the requirements. The bill also establishes a requirement that state agencies and local governments post prevailing wage rates and hours of labor in areas readily accessible to persons employed on the project or in sites regularly used for posting notices.

The bill makes a contractor that fails to pay the prevailing wage rate or overtime pay to an employee as required under the prevailing wage law liable to the affected employee for not only the amount of unpaid wages and overtime pay, but also for liquidated damages in an amount equal to 100 percent of the unpaid wages and overtime pay.

Finally, the bill includes, for both state and local projects of public works, provisions regarding coverage, compliance, enforcement, and penalties, including a) requirements for affidavits to be filed by contractors affirming compliance with the prevailing wage law; b) record retention requirements for contractors regarding wages paid to workers and provisions allowing for the inspection of those records by DWD; c) liability and penalty provisions for certain violations, including criminal penalties; and d) provisions prohibiting contracts from being awarded to persons who have failed to comply with the prevailing wage law.

Transportation projects

Under current law, for certain highway projects for which the Department of Transportation spends federal money, federal money must make up at least 70 percent of the funding for those projects. DOT must notify political subdivisions receiving aid for local projects whether the aid includes federal moneys and how those moneys must be spent. For certain projects that receive no federal money,

DOT may not require political subdivisions to comply with any portion of DOT's facilities development manual other than design standards. Any local project funded with state funds under the surface transportation program or the local bridge program must be let through competitive bidding and by contract to the lowest responsible bidder. The bill repeals all of these requirements.

Because this bill creates a new crime or revises a penalty for an existing crime, the Joint Review Committee on Criminal Penalties may be requested to prepare a report.

1 **SECTION 1.** 19.36 (12) of the statutes is created to read:

2 19.36 (12) INFORMATION RELATING TO CERTAIN EMPLOYEES. Unless access is
3 specifically authorized or required by statute, an authority may not provide access
4 to a record prepared or provided by an employer performing work on a project to
5 which s. 66.0903, 103.49, or 103.50 applies, or on which the employer is otherwise
6 required to pay prevailing wages, if that record contains the name or other
7 personally identifiable information relating to an employee of that employer, unless
8 the employee authorizes the authority to provide access to that information. In this
9 subsection, "personally identifiable information" does not include an employee's
10 work classification, hours of work, or wage or benefit payments received for work on
11 such a project.

12 **SECTION 2.** 66.0129 (5) of the statutes is amended to read:

13 66.0129 (5) BIDS FOR CONSTRUCTION. The nonprofit corporation shall let all
14 contracts exceeding \$1,000 for the construction, maintenance or repair of hospital
15 facilities to the lowest responsible bidder after advertising for bids by the

21 projected life span; the depositing of gravel on an existing gravel road applied solely

14 **SECTION 9.** 66.0903 (2) to (12) of the statutes are created to read:

15 66.0903 (2) APPLICABILITY. Subject to sub. (5), this section applies to any
16 project of public works erected, constructed, repaired, remodeled, or demolished for
17 a local governmental unit, including all of the following:

18 (a) A highway, street, bridge, building, or other infrastructure project.

19 (b) A project erected, constructed, repaired, remodeled, or demolished by one
20 local governmental unit for another local governmental unit under a contract under
21 s. 66.0301 (2), 83.03, 83.035, or 86.31 (2) (b) or under any other statute specifically
22 authorizing cooperation between local governmental units.

23 (c) A project in which the completed facility is leased, purchased, lease

8 **(3) PREVAILING WAGE RATES AND HOURS OF LABOR.** (am) A local governmental
9 unit, before making a contract by direct negotiation or soliciting bids on a contract
10 for the erection, construction, remodeling, repairing, or demolition of any project of
11 public works, shall apply to the department to determine the prevailing wage rate
12 for each trade or occupation required in the work contemplated. The department
13 shall conduct investigations and hold public hearings as necessary to define the
14 trades or occupations that are commonly employed on projects of public works that
15 are subject to this section and to inform itself of the prevailing wage rates in all
16 areas of the state for those trades or occupations, in order to determine the
17 prevailing wage rate for each trade or occupation. The department shall issue its
18 determination within 30 days after receiving the request and shall file the
19 determination with the requesting local governmental unit.

20 (ar) The department shall, by January 1 of each year, compile the prevailing
21 wage rates for each trade or occupation in each area. The compilation shall, in
22 addition to the current prevailing wage rates, include future prevailing wage rates
23 when those prevailing wage rates can be determined for any trade or occupation in

1 any area and shall specify the effective date of those future prevailing wage rates.
2 If a project of public works extends into more than one area, the department shall
3 determine only one standard of prevailing wage rates for the entire project.

4 (av) In determining prevailing wage rates under par. (am) or (ar), the
5 department may not use data from projects that are subject to this section, s. 103.49
6 or 103.50, or 40 USC 3142 unless the department determines that there is
7 insufficient wage data in the area to determine those prevailing wage rates, in
8 which case the department may use data from projects that are subject to this
9 section, s. 103.49 or 103.50, or 40 USC 3142. In determining prevailing wage rates
10 under par. (am) or (ar), the department may not use data from any construction
11 work that is performed by a local governmental unit or a state agency.

12 (bm) Any person may request a recalculation of any portion of an initial
13 determination within 30 days after the initial determination date if the person
14 submits evidence with the request showing that the prevailing wage rate for any
15 given trade or occupation included in the initial determination does not represent
16 the prevailing wage rate for that trade or occupation in the area. The evidence shall
17 include wage rate information reflecting work performed by individuals working in
18 the contested trade or occupation in the area during the current survey period. The
19 department shall affirm or modify the initial determination within 15 days after
20 the date on which the department receives the request for recalculation.

21 (br) In addition to the recalculation under par. (bm), the local governmental
22 unit that requested the determination under this subsection may request a review
23 of any portion of a determination within 30 days after the date of issuance of the

1 determination if the local governmental unit submits evidence with the request
2 showing that the prevailing wage rate for any given trade or occupation included in
3 the determination does not represent the prevailing wage rate for that trade or
4 occupation in the city, village, or town in which the proposed project of public works
5 is located. That evidence shall include wage rate information for the contested
6 trade or occupation on at least 3 similar projects located in the city, village, or town
7 where the proposed project of public works is located and on which some work has
8 been performed during the current survey period and which were considered by the
9 department in issuing its most recent compilation under par. (ar). The department
10 shall affirm or modify the determination within 15 days after the date on which the
11 department receives the request for review.

12 (dm) A local governmental unit that is subject to this section shall include a
13 reference to the prevailing wage rates determined by the department and to the
14 prevailing hours of labor in the notice published for the purpose of securing bids for
15 the project of public works. Except as otherwise provided in this paragraph, if any
16 contract or subcontract for a project of public works is entered into, the prevailing
17 wage rates determined by the department and the prevailing hours of labor shall be
18 physically incorporated into and made a part of the contract or subcontract. For a
19 minor subcontract, as determined by the department, the department shall
20 prescribe by rule the method of notifying the minor subcontractor of the prevailing
21 wage rates and prevailing hours of labor applicable to the minor subcontract. The
22 prevailing wage rates and prevailing hours of labor applicable to a contract or

1 subcontract may not be changed during the time that the contract or subcontract is
2 in force.

3 (e) No contractor, subcontractor, or contractor's or subcontractor's agent that
4 is subject to this section may do any of the following:

5 1. Pay an individual performing the work described in sub. (4) less than the
6 prevailing wage rate in the same or most similar trade or occupation determined
7 under this subsection.

8 2. Allow an individual performing the work described in sub. (4) to work a
9 greater number of hours per day or per week than the prevailing hours of labor,
10 unless the contractor, subcontractor, or contractor's or subcontractor's agent pays
11 the individual for all hours worked in excess of the prevailing hours of labor at a
12 rate of at least 1.5 times the individual's hourly basic rate of pay.

13 (4) COVERED EMPLOYEES. (a) Subject to par. (b), any person subject to this
14 section shall pay all of the following employees the prevailing wage rate determined
15 under sub. (3) and may not allow such employees to work a greater number of hours
16 per day or per week than the prevailing hours of labor, unless the person pays the
17 employee for all hours worked in excess of the prevailing hours of labor at a rate of
18 at least 1.5 times the employee's hourly basic rate of pay:

19 1. All laborers, workers, mechanics, and truck drivers employed on the site of
20 a project of public works that is subject to this section.

21 2. All laborers, workers, mechanics, and truck drivers employed in the
22 manufacturing or furnishing of materials, articles, supplies, or equipment on the
23 site of a project of public works that is subject to this section or from a facility

1 dedicated exclusively, or nearly so, to a project of public works that is subject to this
2 section by a contractor, subcontractor, agent, or other person performing any work
3 on the site of the project.

4 (b) A laborer, worker, mechanic, or truck driver who is employed to process,
5 manufacture, pick up, or deliver materials or products from a commercial
6 establishment that has a fixed place of business from which the establishment
7 supplies processed or manufactured materials or products or from a facility that is
8 not dedicated exclusively, or nearly so, to a project of public works that is subject to
9 this section is not entitled to receive the prevailing wage rate determined under
10 sub. (3) or to receive at least 1.5 times his or her hourly basic rate of pay for all hours
11 worked in excess of the prevailing hours of labor unless any of the following applies:

12 1. The laborer, worker, mechanic, or truck driver is employed to go to the
13 source of mineral aggregate such as sand, gravel, or stone and deliver that mineral
14 aggregate to the site of a project of public works that is subject to this section by
15 depositing the material directly in final place, from the transporting vehicle or
16 through spreaders from the transporting vehicle.

17 2. The laborer, worker, mechanic, or truck driver is employed to go to the site
18 of a project of public works that is subject to this section, pick up excavated material
19 or spoil from the site of the project, and transport that excavated material or spoil
20 away from the site of the project.

21 (c) A person subject to this section shall pay a truck driver who is an owner-
22 operator of a truck separately for his or her work and for the use of his or her truck.

23 (5) NONAPPLICABILITY. This section does not apply to any of the following:

10 contractor, subcontractor, contractor's or subcontractor's agent, or individual for
11 performing the work.

12 (c) Minor service or maintenance work, warranty work, or work under a
13 supply and installation contract.

14 (f) A project of public works involving the erection, construction, repair,
15 remodeling, or demolition of a residential property containing 2 dwelling units or
16 less.

17 (g) A road, street, bridge, sanitary sewer, or water main project that is a part
18 of a development in which not less than 90 percent of the lots contain or will contain
19 2 dwelling units or less, as determined by the local governmental unit at the time of
20 approval of the development, and that, on completion, is acquired by, or dedicated
21 to, a local governmental unit, including under s. 236.13 (2), for ownership or
22 maintenance by the local governmental unit.

23 (8) POSTING. A local governmental unit that has contracted for a project of

1 public works shall post the prevailing wage rates determined by the department,
2 the prevailing hours of labor, and the provisions of subs. (10) (a) and (11) (a) in at
3 least one conspicuous place on the site of the project that is easily accessible by
4 employees working on the project, or, if there is no common site on the project, at the
5 place normally used by the local governmental unit to post public notices.

6 (9) COMPLIANCE. (a) When the department finds that a local governmental
7 unit has not requested a determination under sub. (3) (am) or that a local
8 governmental unit, contractor, or subcontractor has not physically incorporated a
9 determination into a contract or subcontract as required under this section or has
10 not notified a minor subcontractor of a determination in the manner prescribed by
11 the department by rule promulgated under sub. (3) (dm), the department shall
12 notify the local governmental unit, contractor, or subcontractor of the
13 noncompliance and shall file the determination with the local governmental unit,
14 contractor, or subcontractor within 30 days after the notice.

15 (b) Upon completion of a project of public works and before receiving final
16 payment for his or her work on the project, each agent or subcontractor shall
17 furnish the contractor with an affidavit stating that the agent or subcontractor has
18 complied fully with the requirements of this section. A contractor may not
19 authorize final payment until the affidavit is filed in proper form and order.

20 (c) Upon completion of a project of public works and before receiving final
21 payment for his or her work on the project, each contractor shall file with the local
22 governmental unit authorizing the work an affidavit stating that the contractor has
23 complied fully with the requirements of this section and that the contractor has

1 received an affidavit under par. (b) from each of the contractor's agents and
2 subcontractors. A local governmental unit may not authorize a final payment until
3 the affidavit is filed in proper form and order. If a local governmental unit
4 authorizes a final payment before an affidavit is filed in proper form and order or if
5 the department determines, based on the greater weight of the credible evidence,
6 that any person performing the work specified in sub. (4) has been or may have been
7 paid less than the prevailing wage rate or less than 1.5 times the hourly basic rate
8 of pay for all hours worked in excess of the prevailing hours of labor and requests
9 that the local governmental unit withhold all or part of the final payment, but the
10 local governmental unit fails to do so, the local governmental unit is liable for all
11 back wages payable up to the amount of the final payment.

12 **(10) RECORDS; INSPECTION; ENFORCEMENT.** (a) Each contractor,
13 subcontractor, or contractor's or subcontractor's agent that performs work on a
14 project of public works that is subject to this section shall keep full and accurate
15 records clearly indicating the name and trade or occupation of every individual
16 performing the work described in sub. (4) and an accurate record of the number of
17 hours worked by each of those individuals and the actual wages paid for the hours
18 worked.

19 (b) The department or the contracting local governmental unit may demand
20 and examine, and every contractor, subcontractor, and contractor's or
21 subcontractor's agent shall keep, and furnish upon request by the department or
22 local governmental unit, copies of payrolls and other records and information
23 relating to the wages paid to individuals performing the work described in sub. (4)

1 for work to which this section applies. The department may inspect records in the
2 manner provided in ch. 103. Every contractor, subcontractor, or agent performing
3 work on a project of public works that is subject to this section is subject to the
4 requirements of ch. 103 relating to the examination of records.

5 (c) If requested by any person, the department shall inspect the payroll
6 records of any contractor, subcontractor, or agent performing work on a project of
7 public works that is subject to this section as provided in this paragraph to ensure
8 compliance with this section. On receipt of such a request, the department shall
9 request that the contractor, subcontractor, or agent submit to the department a
10 certified record of the information specified in par. (a), other than personally
11 identifiable information relating to an employee of the contractor, subcontractor, or
12 agent, for no longer than a 4-week period. The department may request that a
13 contractor, subcontractor, or agent submit those records no more than once per
14 calendar quarter for each project of public works on which the contractor,
15 subcontractor, or agent is performing work. The department may not charge a
16 requester a fee for obtaining that information. Certified records submitted to the
17 department under this paragraph are open for public inspection and copying under
18 s. 19.35 (1).

19 (d) Section 103.005 (5) (f), (11), (12), and (13) applies to this section, except
20 that s. 103.005 (12) (a) does not apply to a person who fails to provide any
21 information to the department to assist the department in determining prevailing
22 wage rates under sub. (3) (am) or (ar). Section 111.322 (2m) applies to discharge

1 and other discriminatory acts arising in connection with any proceeding under this
2 section, including proceedings under sub. (11) (a).

3 (11) LIABILITY AND PENALTIES. (a) 1. A contractor, subcontractor, or
4 contractor's or subcontractor's agent who fails to pay the prevailing wage rate
5 determined by the department under sub. (3) or who pays less than 1.5 times the
6 hourly basic rate of pay for all hours worked in excess of the prevailing hours of
7 labor is liable to any affected employee in the amount of his or her unpaid wages or
8 his or her unpaid overtime compensation and in an additional amount as liquidated
9 damages as provided under subd. 2. or 3., whichever is applicable.

10 2. If the department determines upon inspection under sub. (10) (b) or (c) that
11 a contractor, subcontractor, or contractor's or subcontractor's agent has failed to
12 pay the prevailing wage rate determined by the department under sub. (3) or has
13 paid less than 1.5 times the hourly basic rate of pay for all hours worked in excess of
14 the prevailing hours of labor, the department shall order the contractor to pay to
15 any affected employee the amount of his or her unpaid wages or his or her unpaid
16 overtime compensation and an additional amount equal to 100 percent of the
17 amount of those unpaid wages or that unpaid overtime compensation as liquidated
18 damages within a period specified by the department in the order.

19 3. In addition to or in lieu of recovering the liability specified in subd. 1. as
20 provided in subd. 2., any employee for and on behalf of that employee and other
21 employees similarly situated may commence an action to recover that liability in
22 any court of competent jurisdiction. If the court finds that a contractor,
23 subcontractor, or contractor's or subcontractor's agent has failed to pay the

8 5. No employee may be a party plaintiff to an action under subd. 3. unless the
9 employee consents in writing to become a party and the consent is filed in the court
10 in which the action is brought. Notwithstanding s. 814.04 (1), the court shall, in
11 addition to any judgment awarded to the plaintiff, allow reasonable attorney fees
12 and costs to be paid by the defendant.

13 (b) 1. Except as provided in subds. 2., 4., and 6., any contractor, subcontractor,
14 or contractor's or subcontractor's agent who violates this section may be fined not
15 more than \$200 or imprisoned for not more than 6 months or both. Each day that
16 any violation continues is a separate offense.

17 2. Whoever induces any individual who seeks to be or is employed on any
18 project of public works that is subject to this section to give up, waive, or return any
19 part of the wages to which the individual is entitled under the contract governing
20 the project, or who reduces the hourly basic rate of pay normally paid to an
21 individual for work on a project that is not subject to this section during a week in
22 which the individual works both on a project of public works that is subject to this
23 section and on a project that is not subject to this section, by threat not to employ, by

3 3. Any individual employed on a project of public works that is subject to this

7 the compensation to which he or she is entitled under the contract, or who gives up,

10 which the individual works both on a project of public works that is subject to this
11 section and on a project that is not subject to this section, is guilty of an offense
12 under s. 946.15 (2).

13 4. Whoever induces any individual who seeks to be or is employed on any
14 project of public works that is subject to this section to allow any part of the wages
15 to which the individual is entitled under the contract governing the project to be
16 deducted from the individual's pay is guilty of an offense under s. 946.15 (3), unless
17 the deduction would be allowed under 29 CFR 3.5 or 3.6 from an individual who is
18 working on a project that is subject to 40 USC 3142.

19 5. Any individual who is employed on a project of public works that is subject
20 to this section who knowingly allows any part of the wages to which he or she is
21 entitled under the contract governing the project to be deducted from his or her pay
22 is guilty of an offense under s. 946.15 (4), unless the deduction would be allowed

3 6. Subdivision 1. does not apply to any person who fails to provide any

6 **(12) DEPARTMENT.** (a) Except as provided under pars. (b) and (c), the
7 department shall notify any local governmental unit applying for a determination
8 under sub. (3) of the names of all persons that the department has found to have
9 failed to pay the prevailing wage rate determined under sub. (3) or has found to
10 have paid less than 1.5 times the hourly basic rate of pay for all hours worked in
11 excess of the prevailing hours of labor at any time in the preceding 3 years. The
12 department shall include with each name the address of the person and shall
13 specify when the person failed to pay the prevailing wage rate and when the person
14 paid less than 1.5 times the hourly basic rate of pay for all hours worked in excess of
15 the prevailing hours of labor. A local governmental unit may not award any
16 contract to the person unless otherwise recommended by the department or unless
17 3 years have elapsed from the date the department issued its findings or the date of

11 has owned at least a 25 percent interest on the date the person submits the bid or
12 negotiates the contract or at any other time within 3 years preceding the date the
13 person submits the bid or negotiates the contract, if the business has been found to
14 have failed to pay the prevailing wage rate determined under sub. (3) or to have
15 paid less than 1.5 times the hourly basic rate of pay for all hours worked in excess of
16 the prevailing hours of labor.

17 (e) The department shall promulgate rules to administer this subsection.

18 patching, not including overlays, that has a projected life span of no longer than 5
19 years; cleaning of drainage or sewer ditches or structures; or any other limited,
20 minor work on public facilities or equipment that is routinely performed to prevent
21 breakdown or deterioration.

22 (br) “Multiple-trade project of public works” means a project of public works in

11 (f) "State agency" means any office, department, independent agency,

16 Navigational System Authority, and the Wisconsin Aerospace Authority.

20 performed on the site of the project of public works, and the total labor cost to
21 install the material does not exceed 20 percent of the total cost of the contract.

22 (g) "Truck driver" includes an owner-operator of a truck.

23 **(1m) APPLICABILITY.** Subject to sub. (3g), this section applies to any project of

21 her hourly basic rate of pay; nor may he or she be paid less than the prevailing wage

7 supplies processed or manufactured materials or products or from a facility that is
8 not dedicated exclusively, or nearly so, to a project of public works that is subject to

10 sub. (3) or to receive at least 1.5 times his or her hourly basic rate of pay for all hours
11 worked in excess of the prevailing hours of labor unless any of the following applies:

22 owner-operator of a truck separately for his or her work and for the use of his or her

(a) A single-trade project of public works for which the estimated project cost of completion is less than \$48,000 or a multiple-trade project of public works for which the estimated project cost of completion is less than \$100,000.

(b) Work performed on a project of public works for which the state or the state agency contracting for the project is not required to compensate any contractor, subcontractor, contractor's or subcontractor's agent, or individual for performing the work.

(c) Minor service or maintenance work, warranty work, or work under a supply and installation contract.

(f) A public highway, street, or bridge project.

(g) A project of public works involving the erection, construction, repair, remodeling, or demolition of a residential property containing 2 dwelling units or less.

1 (h) A road, street, bridge, sanitary sewer, or water main project that is a part
2 of a development in which not less than 90 percent of the lots contain or will contain
3 2 dwelling units or less, as determined by the local governmental unit at the time of

6 (4r) COMPLIANCE. (a) When the department finds that a state agency has not

13 indicating the name and trade or occupation of every individual performing the
14 work described in sub. (2m) and an accurate record of the number of hours worked
15 by each of those individuals and the actual wages paid for the hours worked.

16 (b) The department shall enforce this section. The department may demand
17 and examine, and every contractor, subcontractor, and contractor's and
18 subcontractor's agent shall keep, and furnish upon request by the department,
19 copies of payrolls and other records and information relating to the wages paid to
20 individuals performing the work described in sub. (2m) for work to which this
21 section applies. The department may inspect records in the manner provided in
22 this chapter. Every contractor, subcontractor, or agent performing work on a project
23 of public works that is subject to this section is subject to the requirements of this

2 discharge and other discriminatory acts arising in connection with any proceeding

4 (c) If requested by any person, the department shall inspect the payroll

18 **(6m)** LIABILITY AND PENALTIES. (ag) 1. A contractor, subcontractor, or
19 contractor's or subcontractor's agent who fails to pay the prevailing wage rate
20 determined by the department under sub. (3) or who pays less than 1.5 times the
21 hourly basic rate of pay for all hours worked in excess of the prevailing hours of
22 labor is liable to any affected employee in the amount of his or her unpaid wages or

3 2. If the department determines upon inspection under sub. (5) (b) or (c) that

9 overtime compensation and an additional amount equal to 100 percent of the

13 provided in subd. 2., any employee for and on behalf of that employee and other
14 employees similarly situated may commence an action to recover that liability in
