According to <u>Section 601 (d) of Coronavirus Aid, Relief, and Economic Security Act</u> (CARES), expenses associated with conducting a recovery planning project or operating a recovery coordination office are eligible for CARES funding. The NCS CARES will provide you with invaluable insight while complying with the eligibility requirements of the CARES Act.

We also have drafted new language for the survey invitations and cover letters, addressing COVID-19 and explaining why it remains important for their local government to survey residents about service delivery and performance.

• The NCS CARES is eligible for CARES Act funds since it can be used to measure and respond to COVID-19 recovery needs. When you conduct an impact assessment (such as The NCS CARES) to understand how to support COVID-19 recovery, those costs should be incorporated in your requests for CARES Act assistance. (Specific procedures for accessing CARES Act resources will vary from State to State.)

We acknowledge the difficult position that many local governments are in as a result of COVID-19 but are confident that The NCS CARES can alleviate some of those stressors in the recovery process.
