Creating 'wellness through balance'

Pilates Plus staff, clients reflect on owner's service to community

"Wellness through balance" — that's the philosophy at the Pilates Plus Wellness Center, a small studio that long-time Upper Marlboro resident Susan Spangler started in 2006 with her husband.

Having recognized a need for alternative health and wellness options in the local area, Spangler wanted to offer high-quality programs at a place where clients can call their own.

"I basically started it because I had my own health and wellness problems," Spangler said in a phone interview last month. "I already had a couple of pretty successful businesses that were running. But every once in a while, your world gets taken down with your

own problems and physical pain.”

For Spangler, opening a gym was out of the question as she believes that exercise and fitness programs alone rarely address most clients’ needs.

Spangler, who would later become a certified pilates instructor, convinced herself to take a leap of faith. She made it her goal to offer a one-stop shop for holistic wellness, complete with a family of professionals who not only have the same desire and passion to serve others, but represent the philosophy of balance in terms of meeting all individual needs as well.

Hence, the Pilates Plus Wellness Center — currently directed and operated by Spangler — came to fruition and has since expanded to serve clients throughout the Maryland region including Bowie, Brandywine, Lothian and Dunkirk.

From Christian yoga for spiritual wellness to counseling for nutritional and life-transition concerns, Pilates Plus aims to provide balance in all aspects of the mind, body and spirit. The center is now a member of nationally recognized organizations like the Pilates Method Alliance and Yoga Alliance, and is also the only studio in downtown Upper Marlboro that offers an array of pilates training equipment.

“We just started attracting a variety of health and wellness professionals like acupuncture and massage and nutrition counseling — sort of all

that good stuff,” she said. “We’ve been doing well for the last 15 years and just loving it. We enjoy helping people get healthy and just expanding, really.”

Thanks to a client who persuaded Susan to contact local press, Spangler said word quickly got out about her “little hidden treasure in Upper Marlboro.”

Pilates Plus was recently recognized by the Business and Professional Women (BPW) of Southern Maryland for its leadership in providing alternative health and wellness programs, classes, private sessions and products, according to Spangler.

Having already been selected for BPW’s prestigious 2016 “Woman of Achievement” award for her outstanding entrepreneurship and dedication to serving the Southern Maryland community, Spangler also received a proclamation from the Town of Upper Marlboro Board of Town Commissioners during a special ceremony last month at the Prince George’s County Administration Building in celebration of National Business Women’s Week.

“We sort of realized when people came to us that they were hurting overall. They were just looking for something to help them,” Spangler said. “Everybody is searching for something and everybody needs something. So the majority of our clients are women, but we don’t discriminate and we have lots of men that come to us and they’re regulars.”

As part of the center’s holistic healing model, Spangler is big on getting people to eat right. Her husband, Dan, grows

food for the studio, including peppers, tomatoes, cucumbers and other fresh produce, which is then given away to clients at no cost.

“Anybody that comes in the door, we take care of them. We try to help them feel better,” Spangler said.

Spangler said the management and staff at Pilates Plus are committed to offering attention and care to meet individual needs. Whether clients seek a massage to manage chronic illness or are an athlete looking for a competitive edge, Spangler’s goal is to provide a loving, caring environment, she said.

“We have so many patients and clients who can’t do anything, but they can do Pilates,” said the mother of two twin boys. “When people come in, they think, ‘Oh my God, this looks like a torture chamber! I cannot do this,’ because the equipment has this look of like Medieval torture. But it’s fabulous — it’s strong equipment that’s classical. It’s built with wood and it has all these springs and chains and all kinds of stuff that you kind of don’t see in the gym. It’s designed so that anybody can do anything and get strong.”

Spangler said the good thing about pilates is that it’s different and it helps to strengthen one’s core. Having a strong core allows people to do more in a safe and effective manner as they work toward holistic wellness, she said.

“You can walk better and you can pull yourself up if you had a surgery. It’s really awesome,” Spangler said. “At the same time, we understand ... pilates

is not [a solution to everything] and that you might need a massage or maybe weight loss is your concern and you might need nutrition help. We’ve just been very blessed to attract very, very qualified people who are compassionate, committed and determined to ensure that our clients get well.”

For acupuncturist Dan Nguyen of Port Tobacco, one of Spangler’s long-time employees, he said he gets a lot of joy in helping his clients feel better.

Nguyen said his techniques depend on each client’s individual need. He offers an array of different styles including Japanese, German, European, Vietnamese and even Korean. “[The feedback from clients has been] really positive,” Nguyen said in a separate interview earlier last week. “I think this therapy, this acupuncture, is the most effective. I’m not only an acupuncturist but I do the herbal medicine, Chinese elbow medicine, Western medicine. [Whatever] is the best therapy for that patient, I will use it.”

Nguyen said acupuncture is effective for healing pain, headaches and also for women who experience premenstrual syndrome, or PMS.

“We combine Western and Eastern medicine together to take care of the patients,” said the Vietnam native.

Nguyen has more than 25 years of education and training alone. He practiced medicine in Vietnam and then came to the states around 1980, working as an engineer at the U.S. Department of the Navy — which he has since retired from six

months ago after 31 years of service — prior to attending school to become a certified acupuncturist and herbalist.

“I would emphasize, our country here [abuses] too much medication,” he said. “All the medication, even herbal medicine, have a side effect. But when [most physicians] use it, they don’t care. The more they dip into medication, the more problems they create in the body, but don’t [acknowledge] it.”

With all his credible experience and training, Nguyen said he is happy to put it to good use at Spangler’s studio — a place he not only considers an amazing wellness center from the core, but also a true blessing to his life.

“It’s like a family here,” said 73-year-old Dunkirk resident Barbara Beers, a regular client who has

trained with Spangler for about 10 to 12 years. “If you haven’t met someone yet, Susan will introduce you to them before a class starts. The people that she has, who teaches other classes, are very well-educated in what they’re doing.”

For other people seeking or in need of holistic healing, Beers said Pilates Plus is the place to be with a great group of professionals who are all committed to helping create “wellness through balance.”

“There are a lot of trainers in this business who think they know a lot and I’ve been injured by them,” Beers said. “Susan is a very genuine and generous person. ... She brings in all sorts of people who she thinks will benefit from what everybody else has to offer.”

to be a program. Rather, it’s a tangible expression of gratitude and a tribute to veterans that have sacrificed and served their country.

Every year, the staff encourages more veterans to not only come out and be recognized, but to also share their personal stories as a testament to the sacrifices they made, she said.

“This was born out of my heart,” Carter said as she stood at the podium. “Somewhere along the lines, something just came to my heart about the veterans because the veterans give up their lives for us. When I say they give up their lives, I don’t just mean maybe they have died in service. But the men and women who are in the [armed forces] and gave up that convenient life, that family life, that work life. You all do that for us and that warrants a ‘thank you.’”

Carter said it’s important to have a sense of appreciation for veterans within the community because it shows others have gratitude, an awareness and an understanding of their contributions and values.

In return, veterans and their families get a sense of more de-

termination, hope and support as they readjust to civilian life.

“Every person’s service is significant and every person’s service is important,” she said.

“We had to restore law and order in the nation,” said retired U.S. Army Col. Thearon Williams, who spoke about his experience serving in Iraq, from 2008 to 2009, as a team advisor to the Iraqi National Police chief. “Sometimes we take for granted, here in America, that you wake up and there’s a police force readily available to answer the call. There’s a fire department readily available to answer the call. There are public services that happen as need be.

“But in Iraq, once we came in and took over the military mission, we helped restore those basic services of government,” Williams said. “And along with that, we had to train other folks that were there on how to provide those public services.”

Williams — a member of the Buffalo Soldiers Motorcycle Club of Central Maryland, who now works as a contractor for the Defense Health Agency in Virginia — said he is glad to have served his country and encourages more veterans to continually promote the history and legacy of the country’s forgotten heroes.

Williams’s fellow comrade,

Jeffrey Freeland of La Plata, is also a retired U.S. Army colonel. Freeland publicly spoke about his experience for the first time Saturday.

Having served two 15-month tours in Iraq and a year-long tour in Afghanistan, Freeland said spending time away from his family was indeed a hurdle.

But for Freeland, a former commander, the biggest challenge was dealing with the loss of 16 soldiers and attending 160 memorial services for the fallen heroes he knew and loved like his own family.

Instead of grieving, Freeland said he and his wife spend every Veterans Day with two of his soldiers — who have lost limbs — dealing with life after war.

“We take their families out to dinner,” he said. “I always tell people that ... there’s nothing better than protecting your country and serving with the man to your right and to your left. There’s definitely a bond that you can’t even talk about unless you’ve been there. The interviews that you really need to think about are the families — those kids. When I started deploying, my daughter was about 4 years old. When I finished deploying, she was about 12 and I lost a lot of time with her.”

“Kids and wives suffer quite a bit. Veterans suffer, too, but I will

tell you — the families suffer a bit as well,” Freeland continued. “Every day my daughter went to school, people were saying, ‘Your daddy is going to get killed.’ Or with my wife, every time she looked at the TV, [she would wonder if I had been killed]. ... But I love my country and I’ll do it again.”

When it comes to serving veterans and their families, VConnections Inc. is a results-oriented organization that provides mobile services, outreach programs and support in the areas of education; health and wellness; benefits and claims; education and support; transitional housing; military relocation; legal aid; local, state and federal employment; and community resources.

The organization partners with local, state and federal businesses to expand opportunities through workshops and webinars; workforce development services; job fairs; college prep assistance; family counseling services; support seminars for servicewomen; and advocacy for veterans’ concerns and issue at the local, state and federal level, according to a VConnections Inc. brochure.

“I stress family,” said Buffington, who founded the organization in 2013. “Whether it be mom or dad coming back, it’s a huge adjustment.”

According to Buffington, veteran populations located in the rural areas of the country are most underserved. That is why VConnections aims to educate veterans and their families about resources that are readily available to them — all in an effort to bring them closer together, he said.

“We are finding daily that Veterans Day is every day,” Buffington said. “We have just signed a contract with the College of Southern Maryland to support our student veterans who are transitioning back home. We’re looking to partner — that’s the key.”

“I think it’s shameful for any of our veterans to be discharged and then, for any reason, come home and be homeless,” Muse said. “I get the calls from active service persons who are dealing with the problems of relocation — having to fit over and over again into new communities and the stress of their families relocating. The stress of worrying about the safety of their families while they are away.

“We should do better. We have to do better. I know we need to do better. You deserve better,” Muse continued. “You deserve advocacy from our nation in a better way to say that, ‘We have not forgotten the service that you gave.’”

go, Laurel, High Point, Central, DuVal, Blaendsburg, Gwynn Park, Surrattsville, Potomac, Charles Herbert Flowers, Henry A. Wise Jr., Bowie, Friendly and Northwestern high schools. This year marked the centennial anniversary of the Junior ROTC nationally, according to a program booklet.

“The purpose of the dining-in is threefold,” said Keith Hayes, instructional supervisor for military science under the school system’s office of College

and Career Readiness Innovative Programs. “The unit will assemble and they will commemorate the leaving and the incoming of a new commander, [as well as] celebrate the battles that that unit has been in. What we’ve done, because we have JROTC students, is something called the traditional grog bowl.”

Hayes said the grog bowl consists of mixed wines and alcoholic drinks as part of the ceremony. However, the main idea is to recognize the history and lineage of the Junior ROTC unit as a whole in the nation, he said.

“It’s to give the cadets a

sense of military history and also to teach them etiquette,” Hayes said. “The last thing we do — because the first quarter just ended in Prince George’s County — is also acknowledge our scholars. Those who have achieved in the classroom through recognition of some type of certificate or acknowledgment of their academic achievement.”

In addition, cadets and their instructors commemorated Veterans Day by paying tribute to prisoners of war and people who have gone missing in action in the line of duty, according to Hayes.

“With this event, we want to invest in our ca-

dets so they have camaraderie amongst all of the schools here in P.G. County,” retired U.S. Navy Chief Robert Mack said. “This is a stepping stone for them, once they get into the mess or the officer’s mess, so they have an idea of what will occur at one of these events.”

Mack, who is a Navy Junior ROTC instructor at Suitland High School, said the influx of new Army cadets from Forestville High School — which closed earlier this year — has helped Suitland become a stronger unit.

The merging of Navy and Army cadets is fitting in terms of unity and diversity, especially for Suit-

land’s annual manager’s inspection next month, he said.

“We went from about 125 cadets to 310 cadets,” he said. “It’s amazing to see our kids. They will do anything they need to to make the job happen. The kids merged very well. They were apprehensive for a while because they heard rumors that we were going to take their ranks, do this and do that — but no. The kids that came to our school got to keep their rank from Forestville. We merged that way. ... The kids are doing very awesome.”

Marsha McDowell, 16, is one of Mack’s top students. She said the

Junior ROTC program is awesome because it helps so many kids with their discipline and gives them something to do after school, whether it’s during the weekday or weekend.

“I got an honor roll certificate last year from my commander who was saying that the kids did outstanding for the beginning part of the school year,” said McDowell, an 11th grader at Suitland High. “They show you simple things you should already know, but it helps you learn about important consequences. We support each other — they’re like a second family to me.”

monument's most distinct feature, located at the center, is a cutout that represents the loved one who paid the ultimate sacrifice in the name of freedom, according to the Hershel Woody Williams Medal of Honor Foundation's website.

The purpose of the monument is to not only honor Gold Star Families, but also preserve the memory of the fallen and stand as a stark reminder that freedom is not free.

"I think it's special," retired U.S. Army Lt. Col. Glynn E. Parker, who served in regular active duty for 27 years, said in an interview. "This is the capital of the state. I don't think it could've been in a better place and on Veterans Day. I haven't seen anything like this—mothers and fathers and militants that you see on the memorial itself. If you can give people that's lost somebody, some family members something, this is something you can give them. They'll always remember it."

Parker, a Disabled American Veterans member and commissioner for the Charlotte Hall Veterans Home in St. Mary's County, said the event isn't just about honoring the sacrifice of men and women who served. Rather, it's an opportunity to be around other veterans and encourage them to keep fighting through life's battles, something Parker can relate to as a veteran.

"That's what we do it for," he said. "Most people don't realize this nation is being looked at all the time. There's always enemies that would like to take us down. But we've gotta remain strong."

When it comes to remaining strong, American Gold Star Mothers Inc., Maryland chapter member Rosemarie Ceo said she still has a hard time dealing with the loss of her loved one.

Ceo's youngest son, 23-year-old Cpl. Bernard L. Ceo, was killed in Iraq in 2005 when his convoy caught fire and exploded following a devastating crash. Bernard died in the line of the duty with two other soldiers.

"I know it's been some years but it's still very, very emotional for me," said Ceo, whose son was honored at another memorial tribute last Saturday near the Towson courthouse. "I remember distinctly saying

to him, 'Bernard, nobody joins the military in wartime.' And he said, 'Mom, somebody's gotta do it.' So I knew at that time there was no holding him back. He wanted to serve his country and that's what he did. It's bittersweet, it's bittersweet."

Unfortunately for Ceo, the emotional rollercoaster didn't stop there.

Ceo, who has two older sons that are still alive, said it's been a very traumatic year for her as she lost everything when her house burned down in January. The Baltimore resident is praying to be back in her house by Christmas.

"The significance of that is that my son died in a fire," she said. "The last 10 years have been very trying for me. I think about my son everyday. ... The tears that I cry is the tears of missing him. But they're also tears of joy because of the legacy he had left me."

"This monument means that we're not forgotten and that they're doing everything in their power to try and ease our pain," Ceo continued. "And to show that they really do care for the families, for the mothers. I know everyone keeps saying the mothers but we carried them for nine months so it's very personable for us. To have this on Veterans Day shows that they did everything just to fulfill what we wanted. It's very significant. It makes me feel good."

Established in 1928 and chartered by U.S. Congress in 1984, American Gold Star Mothers Inc. is an organization of mothers who continue to honor their fallen sons and daughters through service to veterans and patriotic events. Almost all chap-

ters throughout the country give many hours of volunteer work and personal service in all hospitals for veterans, as well as to the veterans and their families in their community, according to the organization's website.

The organization also works closely with all veterans' organizations and is a member of the Veterans Administration Voluntary Service's advisory board.

"We are just so elated. We finally have a memorial that is going to be a visual reminder, to all who come to visit, that there is a family member attached to every fallen hero," said Maryland chapter president and chaplain Janice Chance. "Not only did our children sacrifice [their lives], but we sacrificed. Now we have to continue our life, our journey, without our loved ones. Thank God we have those treasured memories that's always in our hearts but people tend to forget the families."

Chance said she is grateful for Medal of Honor recipient Hershel "Woody" Williams — the last surviving World War II veteran from the Battle of Iwo Jima — whose vision helped promote, create and implement Gold Star Families Memorial Monuments throughout the country.

Now, years later, Williams's vision of honoring and paying tribute to Gold Star Families has become a reality. To date, there are 13 monuments which have been dedicated with 39 additional projects in progress, representing a total of 29 states, according to his foundation's website.

"It's so important to me that it's going to be here in Annapolis," Chance said. "A lot of the memorials are in veterans cemeteries, but this is located

right adjacent to World War II Memorial. ... As I look around, this is like a circle of peace. Parents and all the relatives can come to reflect, remember, probably shed some tears and also to celebrate the life of their loved one. They will forever live in our hearts."

"This is an absolutely historic event for the State of Maryland," said Veterans Affairs Secretary George W. Owings III. "It's very important to me because I have several friends' names, former comrades of mine, on the wall in Washington, D.C. ... This signifies how the State of Maryland feels about the heroes we've lost to war, in honoring the Gold Star Families."

One of the non-profit organizations that American Gold Star Mothers Inc. works closely with is Truckin 4 Troops — based in Crownsville — which supports and serves wounded service- men and women by getting them and their families out of the hospital for well-needed rehabilitation.

"It's a really beautiful thing what they're doing for the Gold Star moms," Truckin 4 Troops founder and president Scott Mallary said. "I get a lot of joy out of it—not only us getting joy, but they get a lot of joy coming out to our events. We work with wounded veterans and they get to participate in that. It's pretty humbling."

"It's just fantastic," said retired U.S. Navy vet Robert C. Leib, special assistant to Anne Arundel County's executive. "Gold Star mothers are the heart of the service, I think. To have it coincide with Veterans Day just makes it that much more important. And in An-

napolis, which is in many ways the heart of the United States Navy, even makes it better."

For Leib, service runs in the family. His father not only served in the Army, but his brother and brother-in-law both served in the Air Force as well. Leib's cousin also served in the Navy.

"The country has made my life possible. The opportunities for myself and my family—all of us," he said. "It just means a lot to be able to have served."

"One of the things that we tend to forget is that families suffer when we lose our lives in battle," said retired U.S. Army Sgt. Gary Simpson, a Vietnam vet who served from 1967 to 1968. "Even those who've come back with mental scars and physical scars, our families are so important to us. Families deserve all the recognition they can get. We don't survive without them."

Simpson, a father of four, said if he had the opportunity to serve his country again, he'd be right there.

Having a dedication ceremony on Veterans Day is fitting as there is no better day to honor Gold Star Families who have lost and sacrificed a loved one for this country's freedom, Simpson said.

"We're just excited to honor Gold Star Families," said Chase Savage, a member of Operation Second Chance's advisory board who helped bring the project to Maryland. "It's the first monument in the state that recognizes them and their sacrifice. Veterans Day is obviously important but to me, Gold Star Families' sacrifice is everyday; not just one day of the year. We're happy to do it."

PREVAILING HIGHWAY CONSTRUCTION WAGE RATES

On October 27, 2016 the Prince George's County Wage Determination Board adopted the following schedule of prevailing hourly rates of wages to be paid to workers and apprentices employed on Prince George's County highway construction projects bid effective November 28, 2016.

Workers and apprentices employed by contractors and subcontractors in the execution of any contract for highway construction projects are to be paid not less than the prevailing hourly rates of wages applicable to straight time and overtime work.
