## 2026—A Challenging Financial Picture

From a financial perspective, in first quarter of 2026 we have seen large increases in: fuel, food costs, and commodities. In addition, we have proposed increases in water and sewer costs depending on what the Arizona Corporation Commission (ACC) decides for our community. These are the same increases that residents are dealing with; and, as a result the residents are making personal adjustments to handle the increases. SaddleBrooke One is also making strategic decisions to deal with these challenges:

### **Labor**

Over 56% of the Association budget is labor & contract labor. Reviewing the staffing levels within the organization allowed us to make the following changes, providing sizeable cost savings:

The janitorial contract was put out for bid, identifying a lower cost provider which netted a cost reduction of \$20,000 per year. Thanks to our Director of Operations, John Reed, and our Purchasing Agent, Bonnie Morrow.

Turnover causes labor increases due to constant training and development costs. Our HR Generalist, Jason Bilicic, has worked diligently with our Management Team on leadership methods that help deter turnover within our teams, minimize the use of outside contractors, and keep the work in-house.

Our facility maintenance staff has been increased to allow for faster response times and lower costs. Recently, it was noted that a slow-moving sewer line needed attention. Within a couple of days our Facility Maintenance Team secured the required components and changed out the line. Thanks to Jeff Egan & John Reed for the late-night work.

### **Postage**

The cost of mailing a letter is on the rise. Our accounting department has placed a priority on paying vendors on-line/electronically. Thanks to Michael DeWolf, Lisa Koziol, Marcus Peru, and Cathy Howard.

If you would like to help us stamp out mailing costs, please consider using our e-mail billing service versus a paper invoice. In addition, you can sign-up for our automatic payments. Please contact our front office to utilize these optional cost saving processes at 520-825-3048. Or, you can stop by and talk with Amber or Susanna and sign up in person.

### **Fuel**

A new hybrid truck was added for the Patrol Team in November, 2025; this hybrid provides a noticeable savings. Even with the surge in fuel costs, the Patrol department is showing a reduction of over \$1,000 in gas and oil for the 1<sup>st</sup> quarter of 2026.

## Food

How do you run a restaurant with food cost rising in double digit percentages? This is where our volunteer team—the Events Committee shines. This Team is reducing costs by holding additional events, either a buffet or a single choice meal (such as Chef Tables). This allows our F&B Team to know exactly how many people will be at an event. Staffing is easily identified and food preparation allows for minimal waste. Thanks to Charlotte James and her great events Team.

The Executive Chef, Dylan Carothers, is constantly going through the sales items listed for Shamrock, our main food vendor. If a particular item such as salmon is on sale, Dylan will stock up, and run specials with this item. Also noteworthy, are the rebates that we receive monthly, typically averaging \$3,000.

## Utilities

Due to our unseasonable warm weather, natural gas costs are down for the buildings and the pools.

For the proposed water increases, we will need to wait on the ACC to see what is decided. The ACC employs a staff to review all rate cases, it is comprised of engineers, accountants, and legal experts. The latest review by the staff on April 13<sup>th</sup> recommended a lower cost to residential customers. The hearing is scheduled for mid-June so we will have an answer on water costs soon.

For the sewer costs, as a result of combining smaller communities with SaddleBrooke Utility, the proposed costs would be significantly higher for our area. This increase will not be introduced until May 2027. The sewer costs are associated with the size of the water line to the amenity. Our pools do not use a sewer line but do have a 2-inch water line, the proposed cost is \$571.00 per month. We are talking with JW Water on how to exclude the pool areas within the sewer proposals.

As you can see, the Association continues to identify cost-saving proposals and still maintain our service levels. It will be a challenging year for our Team, but we continue to discover new opportunities to address the rising prices.

## Volunteers are at it again!

Special thanks to the Cyclomasters, for cleaning up SaddleBrooke Blvd. This Team has volunteered for years to maintain the entrance to SaddleBrooke.

Also, thanks to the volunteers of Long Realty and SaddleBrooke Community Outreach, they provided the community with a great shred event following tax day.

Volunteers continue to move our community forward. Thank-you.

### The Summer Has Already Begun!

If you feel like the weather has been unseasonably warm, you are 100% correct. Some would argue we didn't even really have a winter. A couple highlights to emphasize the unusually warm weather:

- Tucson recorded its earliest triple digit high temperature on March 19<sup>th</sup>, the earliest by 3 weeks!
- The average temperature for March was an incredible 10.2 degrees above normal!
- The average high temperature for March would rank as the 3<sup>rd</sup> warmest April ever!
- The average temperature for the first 3 months of 2026 was 5.9 degrees above normal!

Due to this warm winter, we are certainly beginning to see signs of early Bermuda activity in most areas of the courses. Mike Phillips has moved up many of his spring applications due to the increased soil temperatures, early Bermuda activity, and warmer than normal weather.

We were happy to help host all of our League Invitational events and have continued to see consistent usage of the courses. The weather is changing and warming up rapidly. This signals many of the upcoming activities scheduled for this summer, in and around the courses. Some of these items occur annually and some are new endeavors for the Golf Staff. Below is a list of some of these items as well as a little background on each one.

Summer Maintenance Closures: Course closures begin this summer the second week of May and are scheduled throughout the summer. These are important maintenance windows for essential cultural practices. Mike Phillips, and the Maintenance Team, will be making the most of these closures with aerification, sodding, drainage updates, and many other items:

Bunker Sand Replacement: Funds were approved to continue the process of replacing bunker sand that is no longer performing adequately on all three (3) courses. This work will take place over the summer and early fall, with the goal of completion prior to courses re-opening from overseed. Bunkers in process will be Ground Under Repair as needed.

Fairway Cultural Activity: After a 6-year program to cap our existing native soil rootzone with 3-5 inches of sand, we are continuing a new phase with our summer cultural program on fairways. Mike, and his Team, will now pull cores of sand from the

new sand rootzone in June and July and essentially recycle the sand as a form of topdressing. The cores will be broken up and the sand returned to the growing environment. A much smaller amount of new sand will be required this summer and moving forward.

The entire Golf Team looks forward to another productive and busy summer, hopefully with a positive monsoon. Thank you for your continued support and we look forward to seeing you on and around the courses.

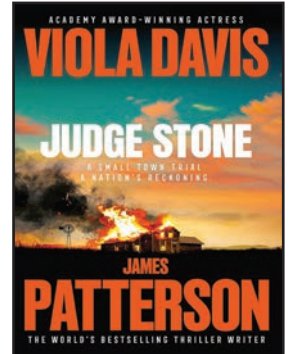
# What's New at the Library?

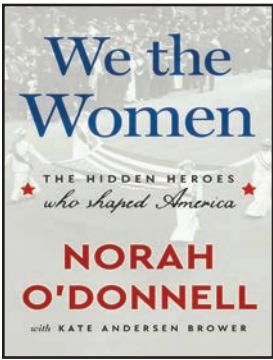
**LIFE: A love Story** by Elizabeth Berg is about finding richness in life at any age, emphasizing that small amounts of moments and objects hold significant meaning.

Peerless historical fiction writer, Marie Benedict unfolds the story of Hatshepsut, the forgotten female pharaoh, in **Daughter of Egypt**.

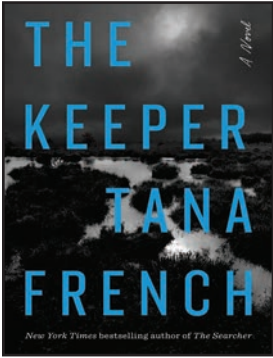
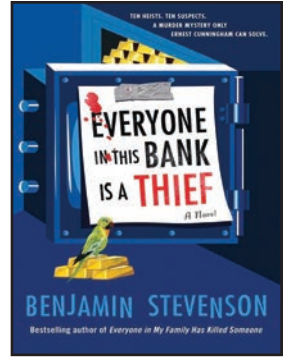




Norah O'Donnell steps away from the TV anchor desk to celebrate **We, The Women** with a book that highlights the overlooked contributions of women throughout U.S. history.

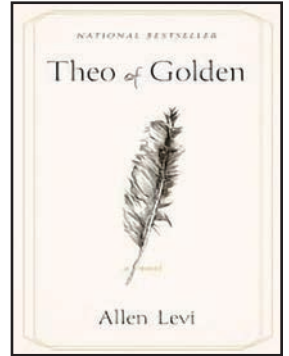

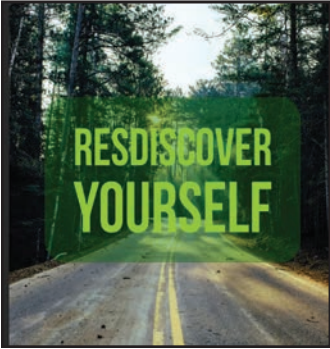

## UNDERSTANDING OUR WALLS: GUIDELINES AND PERMITS

**M**aintaining the beauty and structural integrity of SaddleBrooke One is a shared responsibility, especially when it comes to the walls that define our properties. Whether you are looking to repair a shared **Party Wall** or a **Perimeter Wall** bordering a common area, please keep these key requirements in mind:

- **Permits & Height:** All wall alterations require an **ALC permit**. Walls are limited to seven block courses (approx. 5 feet), measured from the highest adjacent grade. These walls cannot extend past the front of your home.
- **Neighbor Consent:** For Party Walls (on a property line between lots), you must obtain written agreement from your neighbor and all alterations on both sides shall be made to match each parties existing color and texture.
- **Management Inspection:** Perimeter Walls (bordering streets or common areas) require an inspection and approval by SaddleBrooke One Common Grounds before the ALC reviews your permit. This check ensures structural integrity and privacy standards are met.



In order to speed up the permit approval process and cut wait time, you can **SCHEDULE YOUR ALC APPOINTMENT ONLINE** in one of four windows (9:00, 9:30, 10:00 and 10:30). The link is available on the SB1 website.

The **ONLINE EXTERIOR PAINT PROCESS** is easy. Go to the website ([www.saddlebrooke.org](http://www.saddlebrooke.org)) and to the ALC section, follow the online directions, make your selections from the ALC approved colors and once your application is completed by you it will be forwarded to the ALC for action and you will be notified when it is ready.



ALC Meetings are held 1st and 3rd Thursday of the month at 9:00 am. Signups will be in the Coyote South room, where you will wait your turn. If you don't have an online appointment, it will be on a first come, first served basis. You will be escorted to the meeting room when it is your turn.
