<b>Subject:</b>	<b>Woolsey Fire Area Film Permit Policies</b>

Malibu is currently in a state of disaster recovery due to the impact of the Woolsey Fire in November 2018. Due to this situation, we have established conditions that will be followed until further notice:

1. The issuance of a film permit will be at the discretion of the City designee. If another disaster condition occurs, permits will be cancelled and production will not proceed or will be stopped. Refunds will be issued.
2. Permits for after hours filming will not be allowed in the fire areas.
3. Permits will be issued to locations east of Malibu Canyon Road.
4. Every location west of Malibu Canyon Road will be evaluated relative to safety, utility concerns, debris removal and reconstruction issues.
5. Driving scenes will be limited only to areas outside of the fire impacted zones.
6. Parking on city streets will remain very restricted, use offsite parking.
7. Use of the Los Angeles County beaches will be governed by Beaches and Harbors. This is a dual permit with FilmLA and the City of Malibu.
8. Use of State Parks/Beaches will be governed by the CA Film Commission.
9. There will be no filming in the following areas:
