## **CALL FOR ENTRY**

### **Movable Murals**

Celebrating Watsonville's Culture & History

### **250 Main Street, Watsonville**

Presented by Pajaro Valley Arts and the City of Watsonville

**Deadline May 6, 2019**

Exhibit Dates: July 4, 2019 – Approximately May 31, 2020

*Movable Murals* is a joint project of PVA and the City of Watsonville which provides outdoor, semi-permanent hanging space for muralists and artists utilizing digital media and/or painting to create temporary installations.

Selected artists/community groups will be provided 4' x 8' sheets of primed marine plywood upon which the painting, wheat pasting, or digital media will be applied. Completion of artwork will take place at artists' studios, or location of artists' choice, **and will not be created on-site.**

Completed panels will then be installed by the City of Watsonville. Your mural/artwork will be viewed in this location for approximately 6-12 months, at which time different artists/community groups will be offered the opportunity to create upon the same surface/plywood. Artists will be paid a \$250 per panel (4' x 8') stipend to offset costs of paint/printing. In this call for artists and community members, we are looking for work that:

- Shows a high degree of artistry
- Involves the community in the creation of the artwork
- Promotes a positive image of the people and community of Pajaro Valley
- Focuses on topics such as pedestrian and traffic safety, or Pajaro Valley's history, people, neighborhoods, landscape, arts and culture


### **Sites and Sizes**

There are four installation sites available at 250 Main Street. You may apply for one or more sites. Subject matter in each should relate to each other. Panels are separated architecturally by bricks and columns (see photo) and are located on the Main Street side of the City Building.

- Location # 1: Four individual 4' x 8' panels to the left of the main entrance (See Photo)
- Location # 2: One 8' x 8' square set next to the City of Watsonville signage in the front of the building to the right of the main entrance (see photo)
- Location # 3: One 8' x 20' continuous rectangular grouping located one column over (middle section) from the 8' x 8' square (see photo)
- Location # 4: One 8' x 20' continuous rectangular grouping located two columns over from the 8' x 8' square (see photo)



**ENTRY PROCEDURE**

- Submit the completed entry form with your choice of location(s) indicated
- A maximum of 4 conceptual drawings/images in jpeg form no larger than 300 dpi each with the longest side 7 inches. Your last name and title of the piece must be included in the file name. If you need assistance digitizing your drawings, please contact [hedwig@pvarts.org](mailto:hedwig@pvarts.org)
- Entries must be received by May 6, 2019
- The week of May 14, 2019 the entries will be reviewed and selected artists/community groups notified
- May-June: work completed and delivered to the City for installation.

#### **DELIVERY/INSTALLATION INFORMATION**

- If you are unable to transport the 4' x 8 ' panels, please indicate so on your entry form so we can assist you with transportation
- Digital images and paint: Artists supply their own materials for application and/or painting the murals. Paints used must be light-fast high-quality, water-based acrylics. Digitally printed images must be able to withstand weather conditions and be reasonably light fast for a minimum period of 6 months.
- Graffiti: If any of the murals are damaged by graffiti, the City will notify PVA. PVA will contact the artist for repair. The artist will have 48 hours to remove or cover the graffiti. If the graffiti cannot be removed or covered to an extent acceptable to the City, the City reserves the right to remove the mural
- Completed artwork becomes the property of Pajaro Valley Arts, however, copyright remains with the artists. Panels are intended for re-use/multiple applications.

PVA and the City reserve the right to photograph any submitted work for publicity, promotional and archive purposes. Copyright remains with the artist.
