ITINERARY

April 4, 2025 - U.S.A.: Depart from USA **April 4, 2026 - DEPART USA - Flight to Sardinia ALGHERO.** Depart USA with connecting flight to the Italian island Sardinia, the second largest island in the Mediterranean.

April 5, 2026 - Sardinia / Olbia / Alghero: Arrive at Olbia airport with a connection flight. Upon arrival, proceed to the baggage claim and after clearing customs you will be met by your tour manager Oliviero who will escort you throughout this exciting trip. Transfer to your Hotel located in the pretty little town of Alghero. Time to unpack and relax before a nice guided walk to discover **Alghero**, although part of the kingdom of Italy for many generations, this lovely old town still retains an air of the Spanish region of Catalonia since it once formed part of the kingdom of Aragon. The local residents still speak a Spanish dialect. Many of the older buildings are in a Catalan Gothic style reminiscent of Barcelona. See sights including the harbor, and the Cathedral Santa Maria and Piazza Ginasio in the heart of the old town. Enjoy a fantastic sunset from the Catalan walls facing the blue sea. Enjoy welcome dinner at a local restaurant. Overnight in Alghero **(Dinner)**

April 6, 2026 - AMAZING GROTTOS & MYSTERIOUS NURAGHE - Capo Caccia, Nuraghe Site: After breakfast at the Hotel with the local ferry we sail (sea and weather permitting) along the beautiful promontory of Capo Caccia for an amazing view of the coast. The cape is home to a preserve with a renowned labyrinth of caves, including the Grotte di Nettuno, visit the grottos with your guide. Later you will go to the archeological site of Nuraghe Palmavera for a walking tour. Your guide will explain the significance of these remarkable dwellings dating back to 1300 B.C. and found only in Sardinia. These structures are unique to Sardinia, just as the Aztec pyramids are to Mexico A traditional lunch will be prepared for you at a small farmhouse. Evening at leisure in Alghero **(Breakfast, Lunch)**

April 7, 2026 - NORTHERN SARDINIAN LIFESTYLE – Basilica of Saccargia & Castelsardo: Breakfast at the Hotel and free time to go to the beach or further explore Alghero. Later you depart to the historic town of Castelsardo. Along the way we visit the amazing Basilica of Saccargia the most spectacular Church on the island, emblem of Sardinian Romanesque Architecture. Visit the picturesque village Castelsardo fortified by a 13th century castle and full of handcrafting artisans of carpets, baskets and ceramics. We reach a local winery for winery visit and dinner among the vineyards. Return to Alghero overnight **(Breakfast, Dinner)**

April 8, 2026 - NATURAL BEAUTY - Bosa, Alghero: After breakfast we depart to visit Bosa, the Carthaginian town of Bosa, situated on the River Temo and dominated by the ruins of the Castle Serravalle. Located in one of the most beautiful areas of the island, on the rugged, wild and unspoiled west coast, **Bosa** is an incredible jewel, its "pastel" colored houses, and the imposing Malaspina castle on a rocky hill is definitely one of the must-see towns. It is also the best place to taste the world-famous Malvasia, which you will sample at a local winery where you will stop for visit tasting. Lunch at local restaurant time at leisure. Return to Alghero in the afternoon. Evening at leisure in Alghero **(Breakfast, Lunch)**

April 9, 2026 - Tamuli & CAGLIARI: Breakfast at the hotel and check out, We depart direction Cagliari. Along the way we visit the archeological site of **Tamuli**, particularly interesting because of the six menhirs, three interpreted as having female breasts symbolizing fertility. There are also the remains of three Tombe di Giganti, the large Nuraghe and a number of huts, probably of more recent date built as sheds for the shepherds. In the afternoon arrive in Cagliari. History, art and culture go hand in hand with beautiful beaches, lagoon areas and green parks: Cagliari is the Sardinian jewel of a city that enchants with its majestic architecture, winding alleyways and privileged location directly overlooking the sea. Enjoy the Afternoon at leisure to discover Cagliari. Dinner at local restaurant. **(Breakfast, Dinner)**

April 10, 2026- CAGLIARI: After breakfast meet our tour guide in the lobby. We then embark together on walking tour through the streets of Sardinia's capital. We explore each of Cagliari's three historic neighborhoods, Castello, Stampace and Marina, taking in many of the city's highlights along the way. Admire the Bastion of Saint-Remy, which dates back to 1896. See the Cathedral of Santa Maria Assunta and the Elephant Tower, a medieval fortification built to try and repel the Aragonese invasion of 1323. The afternoon is at leisure. You could head to the coast for a stroll, or grab your beach towel and enjoy a few hours of sunbathing at Poetto Beach, which is also located near the city's historic Roman Amphitheater. **(Breakfast)**

April 11, 2026 - THE INLAND Barumini & SU Gologone: After breakfast check out from Cagliari. Along the way we will stop to explore Barumini, one of the most interesting small towns in Sardinia. Rich in history and natural beauty, it is famous for the presence of the complex of Su Nuraxi, currently the only Sardinian archeological site designated as UNESCO World Heritage Site in 1997, you will be amazed by the beauty of this place and its archeological sites. In the afternoon we reach our Hotel located in Olenia in beautiful natural setting within the mountainous Supramonte district: a rural resort for a truly Sardinian experience a really different style of holiday surrounded by local art and tradition, unspoilt nature and dramatic mountain scenery. After check in time to explore the beautiful property. Enjoy dinner at hotel restaurant. The property is renowned for its restaurant and which serves simple, authentic Sardinian dishes. **(Breakfast, Dinner)**

April 12, 2026 - THE HEART OF SARDINIAN CULTURE- Barbagia, Orosolo: After breakfast at the hotel, the focus of the day is on the traditions of Sardinian life. You will travel through the Barbagia region, considered the heart of Sardinia with its ancient customs that have survived alongside modern life for centuries. You will visit the village of Orgosolo, known for its elaborate murals that document the region's social discontent. Orgosolo is also known for its ancient method of baking bread "Pane Carasau": which you will taste at a local bakery. Lunch will be a unique experience as you dine on suckling pig, lamb and Sardinian cheeses, al fresco in the company of a local shepherd. In the afternoon you return to the hotel to relax before joining a nice farewell dinner. **(Breakfast, Lunch, Dinner)**

April 13, 2026 - Return to USA: After breakfast transfer to Airport for return flight direct to USA. **(Breakfast)**

Passenger Cancellation Policies: No charges other than the non-refundable initial service fee/deposit are levied for individual passengers canceling up to 121 days prior to the commencement of Jet Vacations LLC services. However, services which have been prepaid by Jet Vacations LLC on behalf of individual clients maybe non-refundable, non-exchangeable, non-changeable and/or maybe subject to a cancellation-change fee (e.g. theater tickets, Train tickets, Airline Tickets, Event Tickets, Passes, Entrance fees etc.).

Full cancellation: Failing to pay the contractual deposits (other than the initial non-refundable service fee / deposit) constitutes a cancellation. In the event of non-compliance with the payment due dates, Jet Vacations LLC shall have the right to demand the Customer to immediately pay the outstanding balance. Payment shall then be received by Jet Vacations LLC within eight days as of the date of Jet Vacations LLC's written request. Should payment not be received within this time limit, the group stay shall be deemed to be canceled by the Customer. In the event of full cancellation of the agreement by the Customer, which is not justified by Jet Vacations LLC's failure to meet its obligations, cancellation penalties shall be invoiced & calculated as follows:

- 30 days after reservation: A service fee of \$300 becomes non-refundable.
- Initial service fee/deposit**: non-refundable up to 120 days prior departure.
- From 120 to 91 days prior departure: 50% penalty of the total cost per person
- From 90 to 61 days prior departures: 75% penalty of the total cost per person
- From 60 days to day of departure & no show: 100% penalty of total cost per person.

If a passenger cancellation creates a change in the price schedule, the tour price will be revised based on the remaining number of participants. A passenger becoming a single as a result of a partner's cancellation must pay the single supplement.

Itinerary variation. We will make every effort to operate all tours as advertised. Situations beyond Jet Vacations' responsibility may arise, voluntarily or involuntarily, that require changes or exceptions in the service dates, airport of departure, the itinerary, air and land arrangements, hotels, trains or cruise ports of call. On dates including, but not limited to religious holidays and national celebrations, some monuments and sites may be closed. In these unforeseen circumstances beyond Jet Vacations' responsibility, Jet Vacations LLC reserves

the right to postpone a trip and make date modifications along with substitutions on airlines / conveyances / hotels / cruise ships and any other sites or services as deemed necessary as well as adjust the sequence and/or substitute any hotels/cruise ships and any other sites or services with others of similar category.
