**ANNOUNCEMENT: NEW PROGRAM  
TO HELP NEW YORKERS  
ACCESS INSURANCE COVERAGE FOR  
SUBSTANCE ABUSE AND  
MENTAL HEALTH DISORDERS**

The Office of Mental Health (OMH), Office of Alcohol and Substance Abuse Services (OASAS), and the Department of Financial Services (DFS) have [announced a new program](#) to help ensure all New Yorkers are able to access their insurance coverage for substance use disorders and mental health services.

The new Ombudsman Program, called **Community Health Access to Addiction and Mental Healthcare Project (CHAMP)** will educate individuals, families, and health care providers on their legal rights to coverage, help them to access treatment and services and will investigate and resolve complaints regarding denial of health insurance coverage.

Stephanie Campbell, former Executive Director of Friends of Recovery – New York, a statewide network for people in recovery, will serve as NYS Ombudsman Project Director and oversee implementation of the program for OASAS and OMH.

## **Children's System Transformation Updates**

**IMPORTANT: PROVIDER CLAIMS TESTING FOR  
CHILDREN'S SYSTEM TRANSFORMATION**

The NYS Children's Medicaid System Transformation will begin its implementation on January 1, 2019 with the implementation of three Children and Family Treatment and Support Services: Other Licensed Practitioner (OLP), Community Psychiatric Supports and Treatment (CPST) and Psychosocial Rehabilitation (PSR).

Beginning *no later than December 1, 2018*, it is *\*critical\** that Children's providers designated for the CFTSS listed above who are contracting with Medicaid Managed Care Organizations (MMCOs)



prepare to test claims submissions with the MMCOs for ALL service types transitioning into Managed Care on January 1, 2019 (OLP, CPST, PSR) for which they will be providing.

Based on lessons learned during the Adult Behavioral Health Medicaid Managed Care implementation, testing claims and remittance systems prior to the transition of new specialty services into Medicaid Managed Care will allow MMCOs and Providers to prevent potential claiming and payment issues in advance. This is particularly true for any behavioral health specialty services.

During the adult implementation, a number of behavioral health providers did not test their systems and ran into significant challenges submitting claims to MMCOs. While some providers may already be submitting claims to MMCOs, this does not mean claims for specialty health/behavioral health services will pass through properly.

Providers are responsible to claims test with EACH potential contracted MMCO for EACH new Children's service type offered to ensure claiming systems are ready to bill multiple MMCOs. Providers should contact relevant MMCOs for instructions on how to claims test. **While it is crucial to claims test for all services, providers should prioritize claims testing for OLP, CPST, and PSR going live on January 1.**

Providers can find billing contact information for all MMCOs using the [\*\*MCTAC Plan Matrix\*\*](#). Providers must proactively reach out to their contracted MMCOs to begin conversations around steps for testing. *For agencies who use a clearing house, claims testing should include testing claims through your contracted clearing house. Providers are responsible for ensuring that their contracted clearing houses are aware of all new benefit coding requirements.*
