EATON FIRE SOIL TESTING PROGRAM

In response to an April 15, 2025 motion by the Los Angeles County Board of Supervisors, the Department of Public Health is launching a new soil testing program. Up to \$3 million from the Lead Paint Hazard Mitigation Program has been allocated to fund free soil lead testing for residents living downwind of the Eaton Fire burn area. Wildfire Survivors Urged to Update Invalid Addresses for Tax Refunds

Following the devastating wildfires in January, the Los Angeles County Assessor's Office has worked to provide property tax relief, including temporary reductions in assessed value and, in many cases, property tax refunds, to affected homeowners. However, many refund checks and notices are being returned due to invalid mailing addresses - often because the homes were destroyed.

If you experienced property loss, please update your mailing address to ensure delivery of important property assessment and tax-related documents, including property tax refunds.

Key protections for renters and homeowners impacted by the Los Angeles County wildfires have been extended

On March 7, 2025, Governor Newsom issued an executive order to lengthen until July 1, 2025 the state's price gouging restrictions for rental housing, hotels and short-term housing.

The order also does the following:

- Extends support for survivors sheltering in hotels and short-term housing, and prioritizes fire survivors experiencing homelessness for state-funded housing
- Extends the suspension of laws that would classify occupants of hotels, motels and temporary housing as tenants after 30 days, giving people more time to find alternative housing.
- Prioritizes fire survivors experiencing homelessness by prioritizing them on waiting lists for state-funded housing so they can secure housing faster
- Supports the rebuilding of two commercial corridors in Altadena to their pre-fire character to support small businesses and rebuild walkable, vibrant community spaces.

~**For everyone:** All Federal and State tax filing deadlines have been extended to October 15, 2025, for all county residents and businesses. This includes individual income tax returns and payments, as well as estimated tax payments originally due in 2025. This deadline extension is automatic; you don't have to file anything until October.
