

SAHBA 20 Gun Raffle Official Rules

- 1) Limit of 2,000 tickets will be sold: numbering 0001 to 2,000. Do not lose your raffle ticket as it is required to claim a prize.
- 2) Tickets are \$20 each.
- 3) Anyone who purchases five (5) tickets at a time will be entered in a drawing for one additional gun (Benelli Monteltro) which will be drawn on October 1st. There is no limit to the number of tickets you may purchase.
- 4) Cash and personal checks are accepted for the sale of raffle tickets. Raffle prizes will not be awarded until the check clears the bank. Dishonored checks are subject to additional fees and disqualification from the raffle.
- 5) All prizes are new, factory made firearms.
- 6) Raffle tickets are transferable and make great gifts.
- 7) By obtaining a raffle ticket (either by purchase or as a gift) you attest that you are a law abiding citizen of good moral character, may legally possess the firearm(s) won, have intention of using the firearm(s) only in a legal and safe manner, and will or have already obtained instruction on the safe use and operation of the firearm(s) won.
- 8) Drawings will begin on January 8, 2021. A list of drawing dates is below.
- 9) All firearms won are subject to availability and Scheels reserves the right to make substitutions of equal or greater value.
- 10) Winning ticket numbers and firearm won will be posted on the website www.springfieldareahba.com and on the Springfield Area Home Builders Association Facebook Page. To protect the winner's identity, only the winner's first name and last initial will be posted.
- 11) You must be at least 18 years old and a legal resident of the United States to purchase a ticket.
- 12) Winners must be at least 18 years old to take possession of a rifle or shotgun, and at least 21 years old to take possession of a handgun.
- 13) Winner is responsible for all fees associated with any background check required to take possession of their prize.
- 14) Raffle is void where prohibited.
- 15) It is the sole responsibility for the winning ticket holder to contact Scheels to claim their prize. Winner must present ticket to claim prize (or provide an electronic copy if not local to the area). **ALL PRIZES MUST BE CLAIMED AND TRANSFER COMPLETED WITHIN 60 DAYS OF THE DATE THE TICKET IS DRAWN.**
- 16) Winners have the option of taking winnings in an alternate merchandise equivalent MSRP of the firearm won on the day of the drawing.
- 17) All Federal Bureau of Alcohol Tobacco and Firearms (BATF) rules apply.
- 18) Out of area winners have the option of having their prize transferred to their local FFL dealer for delivery. All firearm transfers will be done through a Federal Firearms Licensed (FFL) dealer,

and all applicable Federal and State laws will apply, including the state laws for the legal residence of winning ticket holder. Winner is responsible for all shipping and transfer fees.

- 19) Winners will be responsible for any applicable Federal, State, and local taxes.
- 20) Transfers will be done by Scheels. Scheels solely reserves the right to change the location and/or dealer for any transfer. Winning ticket holder must make transfer through the Scheels selected dealer, and in accordance with all applicable laws.
- 21) In the event winners need or wish to have the firearm(s) won transferred to another FFL dealer closer to their residence, shipping and any other additional costs involved with the transfer will be the responsibility of winner, and arrangements must be made directly with Scheels or other Scheels selected FFL dealer.
- 22) Winners may be required to verify that ownership of the firearm(s) won is legal in their state, city, or town, prior to taking possession of won prize(s).
- 23) Winning ticket numbers are eligible for the remaining drawings.
- 24) Notification will be sent to the winner and firearm vendor, listing the winner's name and address, raffle drawing date, location of the vendor, the firearm selected for that drawing and/or the value of the prize won, and expiration date of redemption.
- 25) Attempts will be made to notify the winner based on the information provided by the participant (telephone, email, and USPS). It is the sole responsibility of the participant to notify the Springfield Area Home Builders Association of any change in mailing address, email address or phone number.
- 26) At no time will Springfield Area Home Builders Association take possession of any of the firearms involved in this raffle; winners will receive firearms directly from Scheels or designated FFL dealer only, all applicable laws will apply.
- 27) Firearms are not transferrable. The participant designated by the winning raffle ticket must claim the firearm. No straw purchases allowed.
- 28) By purchasing a raffle ticket, you agree that Springfield Area Home Builders Association's liability is limited to the purchase price of the raffle ticket.
- 29) In the event that Springfield Area Home builders Association is unable to contact the winner it is the sole responsibility for the winning ticket holder to contact the Springfield Area Home Builders Association to claim their prize.
- 30) In the event the winner cannot be contacted within 60 days of the drawing, the winning prize value will be transferred to the Springfield Area Home Builders Association as a donation.
