Narcan is available throughout Chicago in wall-mounted Harm Reduction boxes. **ANYONE** can visit a box and pick up Narcan for **FREE**.

To find Narcan at a Harm Reduction box near you, simply enter an address in the search box, and you will get a list of nearby locations.


If you don't know the address, use one of these search methods:




Opioid-Related Overdose Fatalities Citywide


Opioid-related EMS responses citywide, 2021 & 2022 & 2023





Opioid-related EMS responses West Side, 2021 & 2022 & 2023




Opioid-related EMS responses on West Side, July 2023



West Side Overview, July 2023

Community areas included: Austin, East Garfield Park, Humboldt Park, North Lawndale, & West Garfield Park.

- Citywide Opioid-Related EMS Responses, n=977
- West Side Opioid-Related EMS Responses, n=302 (31% of citywide total)

Trends on Chicago's West Side for the Month

- 23% decrease 2022 (n=390) to 2023
*Citywide = 9% decrease 2022 (n=1068) to 2023

Hot Spot Areas on Chicago's West Side

- (Austin) Cicero Ave from Washington to Polk, and area of Laramie to Cicero, West End to Madison
- (East Garfield Park) Area in and around Garfield Park
- (Humboldt Park) Area of Augusta to Chicago, Hamlin to Christiana
- (North Lawndale) Area around Roosevelt corridor, from Keeler to Independence
- (West Garfield Park) Pulaski corridor, especially at Lake, Madison, Van Buren & 290

Austin, July 2023

- Citywide Opioid-Related EMS Responses, n= 977
- West Side Opioid-Related EMS Responses, n=302
- Austin Opioid-Related EMS Responses, n=92
(9% of city, 30% of West Side)

Trends in Austin for the Month

- 26% decrease 2022 (n=124) to 2023

- Cicero Ave from Washington to Polk, and area of Laramie to Cicero, West End to Madison
- Area of Quincy to Congress, Lotus to Laramie
- Area around Central & Kinzie
- Area around Division & Laramie














