Labcorp's medical professional profiles include prescription drugs such as synthetic opiates, benzodiazepines, and other synthetic narcotics, as well as illicit drugs such as marijuana, heroin and cocaine.

Labcorp offers the QuantiFERON®-TB Gold test to aid in the diagnosis of both latent and active infection with Mycobacterium tuberculosis. QuantiFERON®-TB Gold provides a convenient replacement technology for tuberculosis (TB) infection evaluation. QuantiFERON (QFT) testing requires only one blood draw for testing as opposed to multiple office visits to evaluate a tuberculosis skin test.

### Additional Titer Tests

Labcorp offers titer testing for a range of diseases to measure antibodies in the blood for a given disease and provide an efficient check of disease immunity. Titer testing assists the ordering clinician in determining the vaccinations an employee needs and may provide cost savings by avoiding administration of costly, duplicate vaccinations.

Titer testing is commonly used for health care workers such as physicians, nurses, emergency medical personnel, dental professionals, medical and nursing students, and laboratory personnel.
