#### ■ **Down Payments**

- **Self-reporting monthly.** 8% of the policy premium, with a minimum down payment of \$260, is credited back over the payroll cycles.
- **Self-reporting other than monthly.** Down payment is a flat payment of \$260.
- Payroll provider. Down payment is a flat payment of \$260.
- **SmartPay reporting service.** Down payment is a flat payment of \$260.
- Down payment is collected via ACH upon initial set-up of policyholder's account.

# Premium Audit

The initial premium for some business policies is estimated based on past records of operations.

The initial premium for some business policies is estimated based on payroll or sales estimates. Businesses with variable or fluctuating exposures, such as payroll, total cost, sales/receipts and admissions will have estimated premiums on some policies. Typically, policies such as Workers' Compensation, General Liability, Garage Liability and Inland Marine Installation Floater policies are audited. After the policy period ends, a premium auditor conducts a premium audit to determine what the exact insurance exposures were during the policy period. If necessary, the insurance premium is then adjusted to reflect the actual exposures.

### Self-reporting premium audits

Penn National Insurance has partnered with Nexus Insurance Solutions to enhance our premium audit services to our smaller Commercial Lines policyholders.

Smaller Commercial Lines accounts that are selected for self-reporting premium audits will receive communications directly from Nexus with instructions to log in to the Nexus portal, where they can complete and securely upload their audit information securely online, or return the information by phone or fax.

## What information is needed for an audit?

Depending on the type of policy, the auditor will let your client know the records that will be needed in advance. Typically, the audit will include a review of your business operations, as well as financial and business records. Please be assured that we consider confidentiality of the utmost importance, and we keep all information in the strictest of confidence.

- Tools, materials and processes
- Employee job duties
- How and where products/services are delivered
- Tour of facility
- Type of business entity

## How are audits handled for those accounts that have elected Workers' Compensation PayGo option?

When the policy period expires, a final audit request is assigned. After all payroll reporting periods are completed, the policy is endorsed to the payrolls that were reported.

The agent will receive an email as a reminder that this is a PayGo policy and the endorsement credit or debit does not get billed to the Insured. The purpose of the endorsement is to align the policy payrolls with the reported payrolls in our billing system.

The final audit is completed and a final audit statement is generated, which shows the final earned premium, but does not show an amount previously charged or the final credit or debit. A direct bill statement is then generated showing the payments made to SmartPay, the final earned premium and the resulting credit or debit amount. If a debit, the policyholder will pay the invoiced amount. If a credit, a check will be issued to the policyholder.

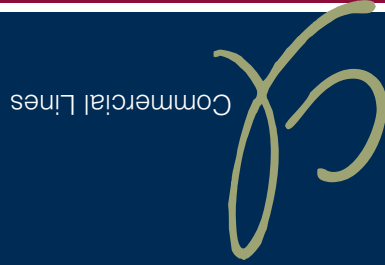
