Flooding

In our community 33143, there is an increased 52% of flooding. My voice speaks about floods and to help you understand that flooding is a repeated climate change issue. Where is Justice in trying to live economically and committing our lives to the Global Climate Crisis? It's more than the CO2 reduction by the year 2030. In the US, the cost annually of flood disasters at about \$8 billion per year. Globally flooding leads most of the four disaster categories of events at 181%, followed by Wildfires, Earthquakes, and Drought.

When FEMA assists disaster victims, they base their assistance on the restored value of the home. Identical homes with identical damage are paid out according to their neighborhood, so rich white people are made whole and poor people are left hurting--getting 50% what wealthier people get.

Carbon Tax

While it is clearly important that each of us as individuals do all we can to reuse, recycle, and reduce our usage of the Earth's resources, the biggest changes must take place at the national and global policy level. We can't expect that governments just do "the right thing" and, because these decisions are driven by economics, we must generate solutions that are financially viable, i.e. that they pay for themselves and generate revenues.

One of these ideas is the notion of a "carbon import tariff" or "carbon tax" that aims to reduce carbon emissions globally (a reduction that will lessen the impact on climate change, help to reduce global warming, which will in turn stem extreme weather, etc.). The European Union is considering a proposal, and a range of carbon tax proposals are under consideration in Congress.
