**Part 1: Cultural Competency – Working with LBGTQ+ Clients and Diverse Family Structures 9:00 am – 9:50 am**

Both the West Virginia Rules of Professional Conduct and the ABA Model Rules of Professional Conduct codify the importance of effective communication with clients (Rule 1.4). Legal practitioners must therefore be mindful of the implications of cross-cultural communications on the attorney-client relationship. Without a cautious approach, cultural misunderstandings and miscommunications may occur. When working with LBGTQ+ clients or families with diverse family structures, attorneys must be mindful of the varying cultural experiences, terminology, and the diverse perspectives that may be presented. In this first CLE session, speaker Ming Wong will discuss the importance of cultural competence and civility as well as ways practitioners can improve in their client communications.

An overview will be provided as to relevant statutory provisions and the differences between regular adoption cases, abuse and neglect adoption cases, and circumstances where pre-birth orders are warranted. Information will be provided as to what adoption attorneys need and need to know (for adoption vs. pre-birth order scenarios). Timing of filings, the required filings, and proposed orders will be discussed for each of the above-mentioned circumstances.
