Dear Governor Hogan,

Maryland is in the midst of an eviction crisis. Over the past year, the COVID-19 pandemic has caused many Marylanders to lose work and face substantial losses in income, jeopardizing their ability to pay rent. Low-income households are especially vulnerable to the economic shocks resulting from the ongoing public health crisis. Our state is the eighth most expensive for housing in the nation. Even before the current public health and economic crises, more than one third of low-income renters in Maryland were cost burdened; these families often sacrifice other critical needs, such as adequate food and health care, in order to make rent. As these households have faced further reductions in income due to the pandemic, it has only become more challenging for them to cover housing costs.

The December federal stimulus package provided Maryland's Emergency Rental Assistance Program (ERAP) over \$400 million in funding to help alleviate this problem, and we anticipate that the state will receive an additional similar allocation from the American Rescue Plan. However, the state and counties are still in the process of standing up programs for distribution of ERAP funds; even as programs launch, it will take weeks to process applications and administer funds. In the meantime, the courts have begun hearing non-payment of rent cases, and families and individuals who have not been able to pay rent are facing eviction despite the fact that they are eligible to receive rental assistance in a few short months.

Maryland needs a targeted 90 – 120 day moratorium on failure to pay rent and tenant holding over eviction hearings in order to provide time for rental assistance programs to go into effect and serve their intended purpose: to prevent mass eviction and displacement.

Right now in many counties across the state, thousands of people are suddenly simultaneously facing eviction and courts are using "rocket dockets" to work through case backlogs. While the state and federal eviction moratoriums currently in place are well-intentioned, they are not stopping many of these evictions because they are not all encompassing and require renters to attend court hearings and provide documentation of income loss. In this challenging time, many people fail to attend hearings for a number of reasons, including COVID-related health concerns and inability to take time off of work. In order to be effective, the 90 – 120 day moratorium should apply to all residential properties and cover all stages of the eviction process.

A targeted 90 – 120 day moratorium on failure to pay rent and tenant holding over eviction hearings would benefit tenants and landlords across the state. It would provide renter households time to apply for assistance and resolve their rent arrears, eliminating the threat of eviction. For landlords, a moratorium on hearings would reduce the time-consuming and costly process of evicting tenants and re-leasing units; once applications are processed and funds are distributed, landlords will receive the rent due to them. Landlords may also be encouraged to provide information on ERAP to their tenants, assist them in applying for funds, and in many cases, can start the application on behalf of their tenants.

We have the funding to keep people in their homes, but now time has become a scarce resource. The situation is urgent. Governor Hogan, it is imperative that you take the critical step of declaring a targeted 90 – 120 day moratorium on failure to pay rent and tenant holding over eviction hearings in order to provide time for assistance to get to families and individuals who critically need it. It is unconscionable for people to be evicted and displaced when, but for a few weeks, they would have the assistance they need to stabilize their housing. Please act now.
