

The organic materials collected in your green cart are taken to a facility where it is turned into nutrient rich compost that makes a great soil amendment to your garden! Using compost can also decrease water usage through moisture retention during droughts.

This compost is derived from green and food waste collected within Alameda and Marin counties. **As such, this compost may contain physical contaminants and should not be used as a top dressing for sports fields or turf applications, in playgrounds, or in areas where it will remain on the surface.** This compost is intended to be used in agricultural applications, flower beds and planters. Till compost into soils 2-6 inches in depth. It is your responsibility to utilize this compost appropriately.
