ORDINANCE NO. 2962

AN ORDINANCE GRANTING TO PUBLIC SERVICE COMPANY OF OKLAHOMA, AN OKLAHOMA CORPORATION, ITS SUCCESSORS AND ASSIGNS, A NON-EXCLUSIVE FRANCHISE FOR THE PERIOD OF TWENTY-FIVE (25) YEARS FROM THE ACCEPTANCE HEREOF TO USE THE PUBLIC WAYS IN THE CITY OF BARTLESVILLE, OKLAHOMA, FOR THE PURPOSE OF BUILDING, EQUIPPING, MAINTAINING, EXTENDING, OWNING AND OPERATING PLANTS AND SYSTEMS FOR THE CONTROL, TRANSMISSION, DISTRIBUTION AND SALE OF ELECTRICITY AND RELATED SERVICES IN AND TO THE CITY OF BARTLESVILLE, AND THE PUBLIC, GENERALLY; TO TRANSMIT ELECTRIC ENERGY TO OR FROM CONNECTIONS, PLANTS AND SYSTEMS IN OTHER LOCALITIES; WHEREBY PUBLIC SERVICE COMPANY OF OKLAHOMA AGREES TO CHARGE LEGAL RATES FOR SUCH SERVICES, TO SELL AND DELIVER TO CITY ALL ELECTRICITY AND RELATED SERVICES REQUESTED BY IT AND TO INDEMNIFY CITY IN SUCH OPERATIONS; AUTHORIZING PUBLIC SERVICE COMPANY OF OKLAHOMA TO PERMIT OTHERS TO ATTACH FACILITIES TO ITS POLES AND STRUCTURES OR TO PLACE SUCH FACILITIES WITHIN, UPON OR ADJACENT TO ITS UNDERGROUND DUCTS AND CONDUITS, AS PROVIDED HEREIN; PROVIDING FOR PAYMENT TO CITY BY PUBLIC SERVICE COMPANY OF OKLAHOMA OF MONTHLY FEES ON GROSS RECEIPTS FROM THE RETAIL SALE OF ELECTRICITY IN THE CITY; DIRECTING THE CALLING OF A SPECIAL FRANCHISE ELECTION TO BE HELD ON MARCH 10, 1998; REPEALING ORDINANCE NO. 2029 OF THE CITY OF BARTLESVILLE, AND ALL OTHER ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith; PROVIDING A PROCEDURE WHEREBY CITY CAN ELECT TO PURCHASE ALL OF THE PROPERTIES OF PUBLIC SERVICE COMPANY OF OKLAHOMA USED FOR OR RELATED TO THE MANUFACTURE, TRANSMISSION, DISTRIBUTION, SALE AND CONTROL OF ELECTRICITY LOCATED WITHIN THE CORPORATE LIMITS OF SAID CITY; AND DECLARING AN EMERGENCY.
