START THE CONVERSATION!

It's never too early to talk with our children about the risks of cannabis use. In the Massapequa's, youth reports using Marijuana as early as 6th grade (2021Core Measures grades 6 - 12).

MODEL POSITIVE BEHAVIOR!

You are a role model for your child so think about what you do and the message it sends. Avoid cannabis use around your child or teen.

GIVE YOUR CHILD WAYS TO SAY NO!



Role play social situations where your child is offered cannabis by a peer and let them know it's OK to say no. Share that if they're ever in a situation they don't know how to handle - they can call you for a ride home.
