



## THE SCBA SCHOLARSHIP FUND

Each year, the South Carroll Business Association (SCBA) awards \$1,000 scholarships to graduating high school seniors who are homeschooled or attend a school located in Carroll County, Maryland. This year eight (8) total scholarships will be awarded.

The SCBA Scholarship Fund was established to assist qualified students in obtaining a degree from accredited academic institutions of higher learning in the fields of business, entrepreneurship, or finance. During the selection process, emphasis is also placed on the student's performance and desire to both maintain a strong academic record while exhibiting humanitarian qualities that have a positive impact on the Carroll County Community.

To be considered for this scholarship, a student must:

- be currently enrolled in a homeschool program or high school located in Carroll County, Maryland
- be a resident of Carroll County, Maryland
- have a grade point average (GPA) of 3.0 or above
- be continuing their education once graduating from high school
- demonstrate an interest in pursuing a career in the fields of business, finance, or entrepreneurship.

- Completed application (including live signature)
- Resume or credential sheet: Please list your school/community activities, awards, leadership experiences, work experiences and/or hobbies/leisure activities. The resume/credential sheet does not have to be in any particular format. It must be a typed and organized list of your activities. No more than 2 pages please.
- At least one recommendation letter
- Unofficial school transcript (no screen shots please)
- Essay: Please describe your current or past involvement in business or finance-related activities and/or curriculum and why you wish to pursue these activities or field of study. Essay should be typed and limited to 500 words.
