The CFPB developed a report on financial education programs for immigrant populations. A small portion of the report discussed the fact that there are financial scams designed to exploit immigrant populations. In their own words, part of the purpose of the report is so "The CFPB, along with policymakers, financial educators, and others concerned with consumer financial

well-being, can use these research findings to develop, spread, and scale targeted approaches to help immigrants with financial decision-making."
