DISCRIPTION

The Security Officer is responsible for undertaking the surveillance of the Company's premises. protection of all staff, assets, and visitors. The Security Officer will be responsible for detecting any. suspicious behavior and preventing vandalism, thefts, or other criminal behavior. The security. Must be well-trained in patrol procedures, report writing, and interpersonal skills. The ideal candidate will inspire, respect authority, and possess high-level situational awareness and use CCTV observation. The goal is to help the company in maintaining excellent working conditions by ensuring the safety and Well-being of all staff members, patron and visiting guests.

RESPONSIBILITIES

- Secures premises and personnel by patrolling property, monitoring surveillance CCTV (closed circuit television) inspecting buildings, equipment, and access points, for any deficiencies.
- Monitors and authorizes entrance and departure of employees, visitors, vendors,
- contractors, and other persons; asking for appropriate documentation and/or authorization prior to entrance into the facility.
- Monitor and stop suspicious people, guard against theft, diversion, and loss, maintaining security of premises.
- Prevents losses and damage by informing violators of policy and procedures, restraining trespassers.
- Completes written reports consisting of observations, reported information, usual occurrences, and suspicious or other questionable activities.
- Maintain alarm and security systems as required by company policy and regulations.
- Comply with all safety procedures and requirements.
- Report any material and/or facility conditions that may affect safety and/or operation.
- Maintain compliance with applicable State and Tribal ordinances and codes.
- Reports all safety, violations, hazardous conditions, and suspicious activities to LBH Director or Operations and Consulting Security Advisor.
