MEMBERSHIP REQUIREMENTS, POLICIES & RECOMMENDATIONS

- All youth participating in Boys & Girls Club of Shinnecock Nation (BGCSN) programming **MUST** be Shinnecock youth between the ages of 4-18 and in grades Pre-K through 12th.
- All youth participants **MUST** obtain a current Boys & Girls Club of Shinnecock Nation membership before participating in programming.
- Non-members are uninsured and therefore not allowed in the facility to participate.
- Club membership is free for all Shinnecock tribal members living on and off territory.
- The 8pm-9pm hour will be reserved for high school students only, unless there is special programming scheduled during that time. All parents must pick up youth that are not in high school by 8pm.
- The Clubhouse facility is monitored full-time through security cameras.
- BGCSN reserves the right to deny, suspend or revoke membership applications or privileges with or without notice at any time should circumstances warrant.

Members Personal Belongings

The Boys & Girls Club of Shinnecock Nation and its staff members are **NOT** held responsible for any lost, stolen or damaged belongings of members. We encourage members not to bring items of value while participating in BGCSN Programming. Members are encouraged to take responsibility for their personal belongings.

"Open Door" Policy

The Boys & Girls Club of the Shinnecock Nation has an "open door" policy. Members ages 13-18 are able to sign in & out and leave the facility on their own. Members who are ages 12 and under are **NOT** allowed to leave the facility on their own, members will need to be picked up by a parent/guardian or must get parent/guardian consent to leave the facility on their own (Club Staff will assist members in obtaining separate consent form).

Member Agreement:

I promise to take care of my Clubhouse and BGCSN property by respecting Club Staff, Club Members, and Club equipment. I also understand that I am expected to behave respectfully and follow all of the rules of the Clubhouse. If I choose not to follow the rules, I may lose my privilege to visit the Clubhouse and/or participate in BGCSN activities.

CONSENT FOR MEMBERSHIP, PARTICIPATION, HOLD HARMLESS, MEDICAL AUTHORIZATION (PLEASE READ CAREFULLY)

By signing below, as a parent or legal guardian of the named child on the previous page, I hereby give my consent for his/her membership in the Boys & Girls Club of Shinnecock Nation.

I give permission for my child to be transported by BGCSN (Southampton Village and areas between Shinnecock Territory “The Neck” and “Westwoods”) and participate in all BGCSN sponsored activities and events, BGCSN administered surveys, and to use all sports/recreational equipment.

I give my permission to the Boys & Girls Club of Shinnecock Nation to share information about the minor child listed on this application with Boys & Girls Clubs of America (BGCA) for research purposes and/or to evaluate the program’s effectiveness. Information that will be disclosed to BGCA may include the information provided on this membership application form, information provided by the minor child’s school or school district, and other information collected by Boys & Girls Club of Shinnecock Nation including data collected via surveys or questionnaires. All information provided to BGCA will be kept confidential. All information received will be kept strictly confidential. Data gathered through these means will be summarized in the aggregate and will exclude all references to any individual responses.

I also give my permission to my child’s School District to exchange information regarding the minor child listed on this application.

I agree to hold harmless BGCSN, members of their board, staff, authorized volunteers and instructors for accidental injury to my child or damage to the child’s property. I further give authority to Club staff, instructors and authorized volunteers in case of accident, injury or sickness of the applicant when in their care to render first aid, provide transportation and admittance to a medical facility. I understand that BGCSN does not cover the applicant with any primary medical insurance coverage and that the parent/guardian is financially responsible for any treatment provided.

BOYS & GIRLS OF SHINNECOCK NATION COVID-19 POLICY & PROCEDURES

- Clubhouse will have a **20 CLUB MEMBER DAILY CAPACITY**. (first come, first serve basis). A waiting list will be made available & BGCSN will notify Club members or parents of available spots.
- Covid-19 updates have been made to the Clubhouse. (*Program area sanitizer dispensers, touchless paper towel dispensers, etc.)

Procedure to enter the Clubhouse facility will be:

- Club Staff will sign in Club members
- Club members will be directed to use hand sanitizer before entering program area
- MANDATORY that all Club staff wear masks (Clubhouse will provide masks to Club members that want a mask)
- Any Club members or Club Staff having Covid-19 symptoms will be sent home. A negative Covid-19 test must be provided to the Boys & Girls Club of Shinnecock Nation before being allowed back into the Clubhouse.
- All Club members that sign out and leave the Club facility will forfeit their spot at the Club for the day and will not be allowed back into Club facility until the next programming day.
- BGCSN will be administering daily cleanliness and disinfecting of program areas and equipment.

ASSUMPTION OF THE RISK AND WAIVER OF LIABILITY RELATING TO CORONAVIRUS/COVID-19

The Boys & Girls Club of Shinnecock Nation has put in place preventative measures to reduce the spread of COVID-19; however, BGCSN cannot GUARANTEE that you or your child(ren) will not become infected with COVID-19. Further, attending the Club could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending the Club and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the Club may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Club employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at the Club or participation in BGCSN programming ("Claims"). On my behalf, and on behalf of my child(ren), I hereby release, covenant not to sue, discharge, and hold harmless BGCSN, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs, or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Club, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Club program.

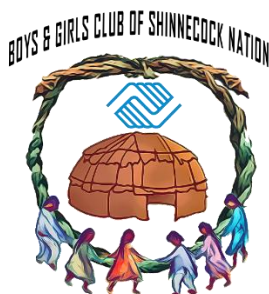
