Kenneth "Ken" Zoucha, MD received his medical degree from the University of Nebraska Medical Center in 1988 and completed his internship and residency in Pediatrics in 1991 during which time he served as the Chief Resident for the Department of Pediatrics from 1990 – 1991. Dr. Zoucha is currently Assistant Professor of Psychiatry and Director of the Addiction Division for the Department of Psychiatry. He is working to start an ACGME fellowship in Addiction Medicine and develop a pilot project for an executive fellowship in addiction medicine to provide an intensive educational experience for current medical providers. Prior to his current position he served as Medical Director of Hastings Juvenile Chemical Dependency Program at the Hastings Regional Center that started in 2012. Dr. Zoucha practiced as a general pediatrician from 1991 until 2010 and was a partner of the Children and Adolescent Clinic, P.C. in Hastings, Nebraska while serving as volunteer faculty at the University of Nebraska Medical Center, Department of Pediatrics. He maintains Board Certification in General Pediatrics and Board Certification in Addiction Medicine and is a Fellow of the American Academy of Pediatrics, Fellow of the American Society of Addiction Medicine and a Diplomate of the American Board of Addiction Medicine.
