



Coronavirus (COVID-19) Update

May 20, 2020

Regular Coronavirus Updates will be emailed Mondays, Wednesdays and Fridays. Normal operating hours for the on-site medical clinic are Monday-Saturday, 6 a.m.-6 p.m.

In observance of Memorial Day, Monday, May 25:

- ***The on-site medical clinic will be closed, but individuals can still call the Flu Hotline.***
- ***The reservation phone line for close-proximity testing will not be manned.***
- ***The Coronavirus Update will not be issued.***

Vogtle 3&4 COVID-19 Testing Status

Since Monday, we have been notified of no additional individuals who have tested positive for COVID-19. The total number remains at 230 positive test results among workers from our site. With each person tested, we act quickly, self-isolating the individuals, along with the personnel who have been in close proximity to them, immediately after learning they have been tested for COVID-19. Currently, approximately 250 workers are self-isolating under these precautionary actions.

As of today, 207 individuals who tested positive for COVID-19 have recovered and are available to return to work. Additionally, 818 individuals who did not exhibit any symptoms but were self-isolating due to being in close-proximity to someone with a positive test result, have cleared their 14-day self-isolation and are available to return to work.

** Individuals who have been directed by their medical provider to self-isolate based on clinical diagnosis, but no laboratory test was conducted. While COVID-19 testing is performed at the Vogtle 3&4 onsite medical clinic whenever deemed appropriate, decisions about testing at offsite facilities are at the discretion of state and local health departments and/or individual clinicians.

*** Individuals who tested positive for COVID-19, have recovered and are available to return to work are listed as "recovered workers." Individuals self-isolating due to being in close proximity to someone with a positive test result, are available to return to work after 14 days of self-isolation and received medical clearance are listed as "close proximity workers."

Medical Clinic Information

- **On-site medical clinic:** The clinic should only be used by those who are showing symptoms and/or feeling ill to allow us to treat those personnel as quickly as possible.
 - Free testing, no copays and access to dedicated medical professionals
 - Open Monday-Saturday, 6 a.m.-6 p.m.
 - Wait time for COVID test results: 24-48 hours

If you are feeling ill, you can also call the flu hotline at 706-437-7600. In case of a medical emergency on the construction site, call the

Emergency Response Team at 706-360-2510. In case of a medical emergency at home, call 911.

- **Close-proximity testing requires reservations:** A reservation hotline has been set up to accommodate appointments for workers who have been in close proximity to another worker who has tested positive for COVID-19.
 - Those who are eligible will be notified that they are able to receive a COVID-19 test at the onsite medical clinic.
 - Reservations may be made by calling 706-437-7679 or 706-437-7670.

Scheduling close proximity-associated testing helps improve the efficiency of our medical clinic as we aim to provide each worker that may be feeling ill with the care they need.
