



Coronavirus (COVID-19) Update

July 10, 2020

Antibody Testing Available

Vogle 3&4 has partnered with Augusta University Medical Center (AUMC) to offer voluntary antibody testing for our workforce. Antibody testing will help individuals determine if they have been exposed to the virus and have possibly developed antibodies, even if they were asymptomatic.

Participation is **completely voluntary** and will be open to all Vogle 3&4 badged workers on a first come, first served basis. Testing will be available 5:30 a.m.-7:30 p.m., **July 13-18, 2020** at two locations on site: the cafeteria in Building 302* and the onsite medical clinic. SNC, SNC subs, Bechtel Field Non-Manuals, Bechtel subs and RCC FNMs who choose to participate will be offered testing times on Monday and Tuesday as well as blocks of time each afternoon for the remainder of the week. RCC Craft who choose to participate will be offered appointment times Wednesday-Saturday. For more information on how to participate, please see [the attached flyer](#).

Once the testing period is complete, we will be made aware of the overall testing results, including the total number of tests administered on site and the total number of positive and negative results. To be clear, specific individual results will remain confidential. Individual results will be provided **only** to the participant and will be accessible through an electronic patient portal provided by AUMC. The site's medical team will not receive any individual test results.

*The cafeteria in Building 302 will be used only for antibody testing purposes July 13-18.

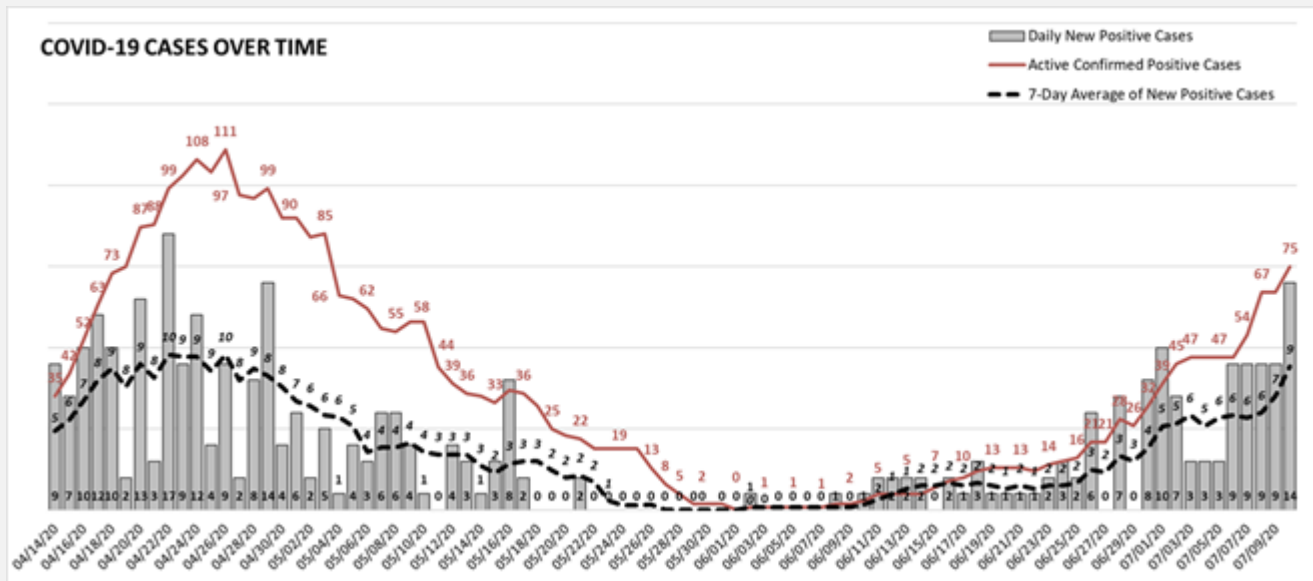
Vogle 3&4 COVID-19 Testing Update

Since Tuesday, July 7, we have been notified of 32 additional individuals who have tested positive for COVID-19.

Site leadership will continue to closely monitor conditions using the data available and will draw on the expertise of health officials, including the latest recommendations from the

Centers for Disease Control and Prevention and the medical professionals providing guidance specifically for our Vogtle 3&4 team.

The proactive measures we've implemented throughout this pandemic to limit the spread of the virus and protect the health and safety of our workforce will continue and evolve based on any new information and guidelines.

Medical Clinic Information

- **On-site medical clinic:** The clinic should only be used by those who are showing symptoms and/or feeling ill to allow us to treat those personnel as quickly as possible.
 - Free testing, no copays and access to dedicated medical professionals
 - Open Monday-Saturday, 5:30 a.m.-7:30 p.m.
 - Wait time for COVID test results: 24-48 hours

If you are feeling ill, you can also call the flu hotline at 706-437-7600. In case of a medical emergency on the construction site, call the Emergency Response Team at 706-360-2510. In case of a medical emergency at home, call 911.
