### **SUMMARY:**

The National Weather Service has issued a FLOOD WATCH for the Guadalupe River area in San Jose, and a FLASH FLOOD WATCH for the Ross Creek area. Residents in these areas should take the following precautions:

- Monitor the news and follow the City of San Jose on Facebook, Twitter and NextDoor for regular updates
- Be ready and tell neighbors to be ready to evacuate, if needed
- Protect your property with sandbags
- Seniors or mobility impaired: Ask family or friends to get you NOW
- Move valuable items to a higher or secure place
- Consider moving pets NOW
- Be ready to move your car/s to high ground
- Pack a bag with important documents, medicines, spare clothes
- Report blocked drains at 408-277-4373

### **Sandbag Locations**

The nearest Valley Water Sandbag location for this area is the Valley Water Winfield Warehouse, located at 5905 Winfield Boulevard, between Blossom Hill Road and Coleman Avenue.
