I authorize my son or daughter to participate in “*The Last Hurrah!*” at Knott’s Berry Farm on **Friday, June 8th**, and acknowledge my understanding and agreement with the following:

- Students must arrive on time to school (7:55). The time between the start of school and departure for Knott’s is designated for iPad turn-in and students are required to be present. 8th graders will leave MCS at 9:20 am and **return between 4:45 and 5 pm**. The scheduled departure time from Knott’s is 4:00 pm. Students may not leave the park at any time prior to departure.
- Cost includes admission and transportation only. Lunch will not be provided. Students must purchase their lunch at the park. Only water may be brought into the park.
- Students are to wear their 8th grade class t-shirt with modest jeans or shorts. Dress code guidelines apply. Please email me if you would like to purchase a new 8th Grade class t-shirt. Only if they do not have their class t-shirt, they may wear an MCS uniform shirt.
- MCS teacher chaperones will travel on the bus to and from Knott’s. In addition, teacher chaperones will be on site for the duration of the visit.
- Students may choose to extend their visit past the 4:00 MCS departure time but you **MUST** indicate the extension on this form. In an effort to ensure the safety of our students, late requests for extensions will not be accommodated. In addition, the designated adult chaperone the student is to be released to must be present outside the front gates at the 4:00 departure time or the student will be required to return to MCS on the bus. Important note: To ensure prompt return, the MCS bus will not wait for adult chaperones to arrive.
