 - Sponsorship is currently at \$14,450 but we have not checked the H&S mail in the last two weeks.
 - We have two of our top sponsorship levels filled at \$4000 and \$2000 with plenty of \$1,000 sponsorship, but we are still looking for \$5,000 and \$3,000 level sponsorships (leads are welcome).

 - Auction ads and requests for donation have been in the virtual backpack, actual backpacks and bulletin.
 - Silent auction items have begun to roll in - currently we have donations from about 30 businesses. We have plenty of others we expect to donate.
 - *One Cause* (company that runs silent auction on phones) call is scheduled for next week
 - Spoken to Mary Tretow and some form of the jail will be present (though the detainees list is still pending). We will have wine pull, gift card wall, cash purse and cash briefcase games and one other monopoly themed game.
 - Settled on Zillies for food. Zillies has provided us with a menu of monopoly themed foods which we will select once the food tasting is complete within the next few weeks.
 - Auctioneer booked - we are working on a DJ (though we could use some information on the AV capabilities SMV already possesses)
 - The Decorating committee meeting is at the school on January 16th at 2:45pm.

○ **Chili Chomp** (Amy Henry, Peter Henry, Jake Zappa)

- Friday Jan 27, 5:30-7:30 in cafeteria.
- Chili drop off 4:30-5pm | Judges eat and judge 5-5:30pm | Awards announced 7pm | Clean up at 7:30pm
- As in past years, planning on serving house "mild" chili, hot dogs, noodles, all the fixings, and water, juice, and soda for kids; and beer and wine for adults. We shop at Costco for most items. Not sure of what to expect for attendance- in most recent years there have been around 40 adults and 80 kids. We will budget based upon spending from the last in-person chili chomp (2020)- do you have records of that? [Katy shared budget numbers with committee.](#)
- BINGO and board games for kids - admittedly I've forgotten where the big bin of games is located. [Not sure if board games are in Home and School, have bingo in H&S closet. Possibly have coloring area for children.](#)
- We will need to check the closet for paper product items already there. (Is the pancake breakfast happening this year? Don't want to take stuff out of the closet that is reserved for that). [Pancake breakfast is happening. Budget was raised to accommodate buying additional supplies as needed.](#)
- We have some adult volunteers already, and will ask Mr. Neuman about kids who need middle school service hours. Volunteers will help set up, serve, and clean up.
- We will contact Mr Fix it to set up a microphone and tables for food & games, as well as coat hangers near the cafeteria. [Mr. Falk should be contacted for microphone, not Mr. Fix it.](#)
- We are working on getting judges. I think Mr Falk is usually in!
- We have had donations for desserts in the past - I will include this on the sign up.

and I took over the Chili Chomp from the Albrecht's , they had obtained gift cards (donations) from the community, and gave a bottle of donated wine as well. Another idea: A monogrammed “chili chomp” apron could be cute for the winner? [Prize for winner is good. Apron is a fine idea!](#)
