Searching For United States Immigration Records

Finding immigration records, such as passenger manifests, requires significant preparation before searching online databases. Understanding how the United States records are organized is key. First, the immigrant's original name, date range of immigration and likely port of origin and port of arrival is identified. Even with ample preparation, sometimes work around searches of naturalization records or emigration records are needed to uncover the information. Immigration record searches sometimes require modification based on the travel time period. "Searching for United States Immigration Records" provides an effective step by step search approach.

After retiring in 2020 from a career in corporate human resources, Terri Conway continued to pursue her passion for genealogy. She gained experience researching her own family that had immigrated to Illinois, Iowa, Wisconsin and Minnesota. Her ancestors primarily immigrated to the United States between 1830-1930, originating in eastern Europe, Germany and the British Isles. Lengthy and difficult to spell surnames are the norm in Terri's family. In August 2021, Terri earned her certificate in genealogy from Boston University and began volunteering at the Family Search Center in Las Vegas. During the past few years, Terri has focused on helping others to locate immigration records as well as research eastern European ancestry.

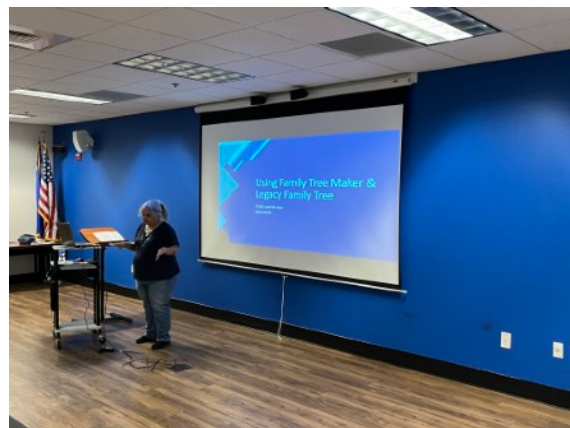

Wins Small Branch Award

CCNGS member, Dr. Linda Miller, Past Governor of the Nevada Southern Branch National Society Sons and Daughters of the Pilgrims, brought home the small branch plaque after the 113th General Court Meeting April 17, 2023 in Washington, D.C. The Robert Orr Harris Award is named after the first Governor General in 1908. This is the first time that this award was given. A plaque was given with the name of the branch. The plaque is kept for a year. However the branch is allowed to apply again.

The lengthy application includes ten categories that need to be covered. Each category receives up to five points. The categories include branch meetings, speakers, community affairs, newsletter, media coverage, donations to National Society Projects, website, representation at General Court and special projection completion.



Sons and Daughters of the Pilgrims

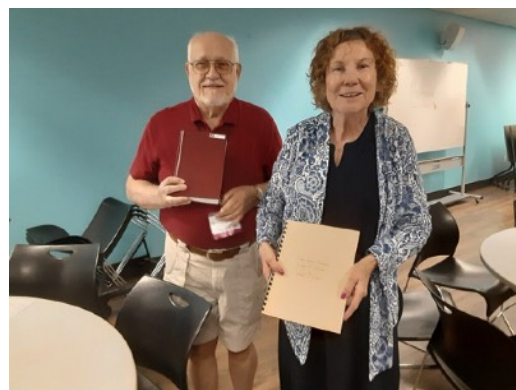

To become a member, you must prove your ancestors immigration to America before 1700 as defined by the Society. Check with Dr. Linda Miller if interested and receive a brochure.

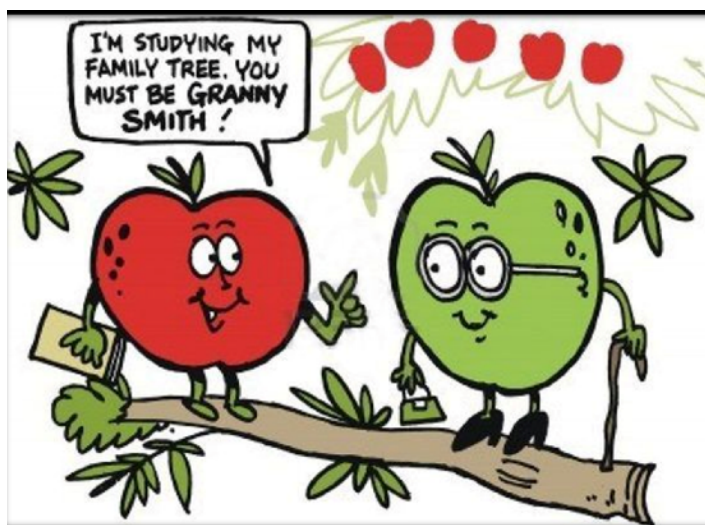
Book Donation To Heritage Room

Censuses are filled with valuable information which initially may be overlooked. We will review the importance and meaning of this data.

However, the information on the census record is only as good as

1. What the informant provided
2. Who provided the information
3. The answers versus the instructions
4. What the Enumerator understood or was there a communication problem
5. The census record being legible
- 6.

Also consider that some census records are missing or deliberately erroneous.

Historic Memorial Day Service at Woodlawn Cemetery By Dr. Linda Miller

The historically established May 30 Memorial Day was conducted by several genealogical groups in honor of two Civil War soldiers buried at the cemetery. The Sons of the Union Veterans of the Civil War with Commander Kurt Dunphy presiding (including CCGS Member Gary Parriott), and William Boone Keith Circle #3 Ladies of the Grand Army of the Republic President Shirley Dunphy presiding (including CCGS Member Dr. Linda Miller), conducted their annual Memorial Day Celebration on May 30 at 12 PM.

Dr. Linda Miller, a Daughters of the Union Veterans member and William Boone Keith Circle #3 member, portrayed Helen J. Stewart, who in 1914 along with other prominent ladies in Las Vegas, persuaded the railroad to donate ten acres of land for a city cemetery. She described in Helen's words how the cemetery would be decorated.

In this historic ceremony which has been celebrated for decades, each group presented wreaths to honor the two Civil War Soldiers William Boone Keith (LGAR Circle #3 namesake), Union Soldier and Joseph Moore Graham, Confederate Soldier, who lie side by side. A few years after the Civil War ended, the men moved to Las Vegas, leaving their families behind and became good friends. When Graham died, Keith purchased a plot for both himself and Graham. Keith had Graham's wife's (Julia) remains sent to Las Vegas to be buried next to her husband. The two veterans from opposite sides of the conflict share a common tombstone. It is believed to be the only grave in the country with a Confederate and Union soldier laying side by side.



The ceremony was also dedicated to the memory of Em and Len Becker. In 1997, Em, President of the Daughters of Union Veterans Elizabeth Benton Fremont Tent #87 and her husband Len, of the Sons of Union Veterans of the Civil War Camp #12, placed a monument between the graves of the two Civil War Soldiers. They were caretakers of the monument until their death a few years ago. Their young relatives attended this ceremony.

USS Nevada Veteran Returns to Normandy

USS Nevada veteran Dick Ramsey returned to Normandy, France to commemorate the 79th anniversary of the DDAY invasion June 6, 2023. He was shown on The Today Show on that morning, shaking hands with the Secretary of Defense, and Donnie Edwards, former NFL linebacker, the founder of the Best Defense Foundation which sponsored his trip. Dick gave them and General Milley USS Nevada commemorative coins.

There were ten days of celebrations, remembrances, and commemorations in honor of the liberation of France. Dick was also sponsored by the Best Defense Foundation last year to Normandy and to Pearl Harbor in December 2021. Dick was part of the USS Nevada 80th anniversary celebration there.

Dick first came to Las Vegas for the 100th anniversary of the USS Nevada in February 2016.

Celebrations were held at the Nevada State Museum, Atomic Museum and other venues. He was then invited to attend the 75th anniversary of the Attack on Pearl Harbor trip coordinated by Dr. Miller which included members of the Daughters of the American Revolution in Nevada and Hawaii. Dick was a keynote speaker at the 80th Anniversary of the Attack on Pearl Harbor Brick Laying Ceremony at the Atomic Museum on Nevada Day October 28, 2022. Unfortunately it had to be on zoom due to his recent stroke.

Dick enlisted in the U.S. Navy in 1943 and was sent to Great Lakes Naval Station for boot camp. He served as a Coxswain, in charge of driving small craft, and was sent to Normandy for the D-Day Invasion on June 6, 1944, aboard the USS Nevada. The invasion on the beaches of France was his first experience in combat. Dick, who will be 100 on Nevada Day this year, and Dr. Charles Sehe, 100 from Mankato, Minnesota who served on the Nevada in all their battles including Pearl Harbor and was interviewed by Channel 3 in 2016 about his service at Pearl Harbor, are the last two living USS Nevada veterans.

State Censuses - Valuable Tool Submitted by: Dramea Brower

State censuses can be as important as the federal census to genealogists but, because they were taken randomly, remain a much under-utilized resource in American genealogy. State censuses often can serve as substitutes for some of the missing federal census records - most notably the 1790, 1800, 1810, and 1890 censuses. Many state censuses also asked different questions than the federal census, thus recording information that cannot be found elsewhere in the federal schedules.

While not all states took their own censuses, and some have not survived, state and local census records can be found in many locations. Most states which took censuses usually did so every 10 years, in years ending in "5" (1855, 1865, etc.) to complement the federal census. These state census records are most often found at the state archives or state library. Many are also on microfilm through a local Family History Center of the Church of Jesus Christ of Latter-day Saints and online via commercial genealogy databases.
