- If we leave the area where we are gathering/meeting, we will tell an adult where we are going before we leave (even if we're leaving with our parents).
- We will use appropriate language.
- We will keep our voices at the right level for the activity we are doing.
- When praying or reading aloud or other activities, we have the right to pass.
- We will maintain confidentiality.
- We will not engage in sexual activity.
- We will use common sense.
- We will not hit each other, etc.

● **We will respect each other.**

- We will listen to each other when they are talking.
- We will make sure everyone who wants to add to the conversation has the chance to speak.
- We will speak kindly of each other.
- We will abstain from inappropriate sexual behavior or other acts of disrespect, including on social media.

● **We will respect our space.**

- We will clean up after ourselves, pick up trash, clean the dinner tables, etc.
- We will use the furniture, etc, in the rooms we utilize in an appropriate manner.
- We will accept responsibility for our part in all damage and necessary repairs to any host property, including damage to vehicles in which we are traveling.
