- 2.** Have made a positive impact on Maine's economy through advancement of natural resource utilization (forest products, agriculture, fisheries, etc.), emerging industries (biotech, software, engineered applications, etc.), or other demonstrable positive economic activity;
- 3.** Works within the commercial lending or economic development community and exemplifies a history of successfully leveraging resources by providing assistance to businesses in the state of Maine.
